Mrs. HOUCHIN, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 6192) to amend the Energy Policy and Conservation Act to prohibit the Secretary of Energy from prescribing any new or amend-

ed energy conservation standard for a product that is not technologically feasible and economically justified, and for other purposes; providing for consideration of the bill (H.R. 7109) to require a citizenship question on the decennial census, to require reporting on certain census statistics, and to modify apportionment of Representatives to be based on United States citizens instead of all persons; providing for consideration of the joint resolution (H.J. Res. 109) providing for congressional disapproval under chapter 8 of title 5, United States Code, of the rule submitted by the Securities and Exchange Commission relating to "Staff Accounting Bulletin No. 121"; and providing for consideration of the bill (H.R. 2925) to amend the Omnibus Budget Reconciliation Act of 1993 to provide for security of tenure for use of mining claims for ancillary activities, and for other purposes.

1 *Resolved*, That at any time after adoption of this reso-
2 lution the Speaker may, pursuant to clause 2(b) of rule
3 XVIII, declare the House resolved into the Committee of
4 the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 6192) to amend the Energy Policy
6 and Conservation Act to prohibit the Secretary of Energy
7 from prescribing any new or amended energy conservation
8 standard for a product that is not technologically feasible
9 and economically justified, and for other purposes. The
10 first reading of the bill shall be dispensed with. All points
11 of order against consideration of the bill are waived. Gen-
12 eral debate shall be confined to the bill and shall not ex-

1 ced one hour equally divided and controlled by the chair
2 and ranking minority member of the Committee on En-
3 ergy and Commerce or their respective designees. After
4 general debate the bill shall be considered for amendment
5 under the five-minute rule. The amendment in the nature
6 of a substitute recommended by the Committee on Energy
7 and Commerce now printed in the bill shall be considered
8 as adopted in the House and in the Committee of the
9 Whole. The bill, as amended, shall be considered as the
10 original bill for the purpose of further amendment under
11 the five-minute rule and shall be considered as read. All
12 points of order against provisions in the bill, as amended,
13 are waived. No further amendment to the bill, as amended,
14 shall be in order except those printed in the report of the
15 Committee on Rules accompanying this resolution. Each
16 such further amendment may be offered only in the order
17 printed in the report, may be offered only by a Member
18 designated in the report, shall be considered as read, shall
19 be debatable for the time specified in the report equally
20 divided and controlled by the proponent and an opponent,
21 shall not be subject to amendment, and shall not be sub-
22 jeet to a demand for division of the question in the House
23 or in the Committee of the Whole. All points of order
24 against such further amendments are waived. At the con-
25 clusion of consideration of the bill for amendment the

1 Committee shall rise and report the bill, as amended, to
2 the House with such further amendments as may have
3 been adopted. The previous question shall be considered
4 as ordered on the bill, as amended, and on any further
5 amendment thereto to final passage without intervening
6 motion except one motion to recommit.

7 SEC. 2. Upon adoption of this resolution it shall be
8 in order to consider in the House the bill (H.R. 7109)
9 to require a citizenship question on the decennial census,
10 to require reporting on certain census statistics, and to
11 modify apportionment of Representatives to be based on
12 United States citizens instead of all persons. All points
13 of order against consideration of the bill are waived. The
14 amendment in the nature of a substitute recommended by
15 the Committee on Oversight and Accountability now print-
16 ed in the bill shall be considered as adopted. The bill, as
17 amended, shall be considered as read. All points of order
18 against provisions in the bill, as amended, are waived. The
19 previous question shall be considered as ordered on the
20 bill, as amended, and on any further amendment thereto,
21 to final passage without intervening motion except: (1) one
22 hour of debate equally divided and controlled by the chair
23 and ranking minority member of the Committee on Over-
24 sight and Accountability or their respective designees; and
25 (2) one motion to recommit.

1 SEC. 3. Upon adoption of this resolution it shall be
2 in order to consider in the House the joint resolution (H.J.
3 Res. 109) providing for congressional disapproval under
4 chapter 8 of title 5, United States Code, of the rule sub-
5 mitted by the Securities and Exchange Commission relat-
6 ing to “Staff Accounting Bulletin No. 121”. All points of
7 order against consideration of the joint resolution are
8 waived. The joint resolution shall be considered as read.
9 All points of order against provisions in the joint resolu-
10 tion are waived. The previous question shall be considered
11 as ordered on the joint resolution and on any amendment
12 thereto to final passage without intervening motion except:
13 (1) one hour of debate equally divided and controlled by
14 the chair and ranking minority member of the Committee
15 on Financial Services or their respective designees; and
16 (2) one motion to recommit.

17 SEC. 4. Upon adoption of this resolution it shall be
18 in order to consider in the House the bill (H.R. 2925)
19 to amend the Omnibus Budget Reconciliation Act of 1993
20 to provide for security of tenure for use of mining claims
21 for ancillary activities, and for other purposes. All points
22 of order against consideration of the bill are waived. The
23 amendment in the nature of a substitute printed in House
24 Report 118-416 shall be considered as adopted. The bill,
25 as amended, shall be considered as read. All points of

1 order against provisions in the bill, as amended, are
2 waived. The previous question shall be considered as or-
3 dered on the bill, as amended, and on any further amend-
4 ment thereto, to final passage without intervening motion
5 except: (1) 30 minutes of debate equally divided and con-
6 trolled by the chair and ranking minority member of the
7 Committee on Natural Resources or their respective des-
8 ignees; and (2) one motion to recommit.
