Mr. COLE, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 2811) to provide for a responsible increase to the debt ceiling, and for other purposes, and providing for consideration of the joint resolution (H.J. Res. 39) disapproving the rule submitted by the Department of Commerce relating to “Procedures Covering Suspension of Liquidation, Duties and Estimated Duties in Accord With Presidential Proclamation 10414”.

1 *Resolved*, That upon adoption of this resolution it
2 shall be in order to consider in the House the bill (H.R.
3 2811) to provide for a responsible increase to the debt ceil-
4 ing, and for other purposes. All points of order against
5 consideration of the bill are waived. The amendment print-
6 ed in the report of the Committee on Rules accompanying
7 this resolution shall be considered as adopted. The bill,
8 as amended, shall be considered as read. All points of
9 order against provisions in the bill, as amended, are
10 waived. The previous question shall be considered as or-
11 dered on the bill, as amended, and on any further amend-
12 ment thereto, to final passage without intervening motion
13 except: (1) two hours of debate equally divided among and
14 controlled by the chair and ranking minority member of
15 the Committee on the Budget or their respective designees
16 and the chair and ranking minority member of the Com-
17 mittee on Ways and Means or their respective designees;
18 and (2) one motion to recommit.

19 SEC. 2. Upon adoption of this resolution it shall be
20 in order to consider in the House the joint resolution (H.J.
21 Res. 39) disapproving the rule submitted by the Depart-
22 ment of Commerce relating to “Procedures Covering Sus-
23 pension of Liquidation, Duties and Estimated Duties in
24 Accord With Presidential Proclamation 10414”. All points
25 of order against consideration of the joint resolution are

1 waived. The joint resolution shall be considered as read.
2 All points of order against provisions in the joint resolu-
3 tion are waived. The previous question shall be considered
4 as ordered on the joint resolution and on any amendment
5 thereto to final passage without intervening motion except:
6 (1) one hour of debate equally divided and controlled by
7 the chair and ranking minority member of the Committee
8 on Ways and Means or their respective designees; and (2)
9 one motion to recommit.
