RESOLUTION

Providing for consideration of the bill (H.R. 788) to limit donations made pursuant to settlement agreements to which the United States is a party, and for other purposes; providing for consideration of the joint resolution (H.J. Res. 98) providing for congressional disapproval under chapter 8 of title 5, United States Code, of the rule submitted by the National Labor Relations Board

relating to “Standard for Determining Joint Employer Status”; and providing for consideration of the joint resolution (S.J. Res. 38) providing for congressional disapproval under chapter 8 of title 5, United States Code, of the rule submitted by the Federal Highway Administration relating to “Waiver of Buy America Requirements for Electric Vehicle Chargers”.

1 *Resolved*, That upon adoption of this resolution it
2 shall be in order to consider in the House the bill (H.R.
3 788) to limit donations made pursuant to settlement
4 agreements to which the United States is a party, and for
5 other purposes. All points of order against consideration
6 of the bill are waived. In lieu of the amendment in the
7 nature of a substitute recommended by the Committee on
8 the Judiciary now printed in the bill, an amendment in
9 the nature of a substitute consisting of the text of Rules
10 Committee Print 118–18 shall be considered as adopted.
11 The bill, as amended, shall be considered as read. All
12 points of order against provisions in the bill, as amended,
13 are waived. The previous question shall be considered as
14 ordered on the bill, as amended, and on any further
15 amendment thereto, to final passage without intervening
16 motion except: (1) one hour of debate equally divided and
17 controlled by the chair and ranking minority member of
18 the Committee on the Judiciary or their respective des-
19 ignees; (2) the further amendment printed in the report
20 of the Committee on Rules accompanying this resolution,

1 if offered by the Member designated in the report, which
2 shall be in order without intervention of any point of
3 order, shall be considered as read, shall be separately de-
4 batable for the time specified in the report equally divided
5 and controlled by the proponent and an opponent, and
6 shall not be subject to a demand for division of the ques-
7 tion; and (3) one motion to recommit.

8 SEC. 2. Upon adoption of this resolution it shall be
9 in order to consider in the House the joint resolution (H.J.
10 Res. 98) providing for congressional disapproval under
11 chapter 8 of title 5, United States Code, of the rule sub-
12 mitted by the National Labor Relations Board relating to
13 “Standard for Determining Joint Employer Status”. All
14 points of order against consideration of the joint resolu-
15 tion are waived. The joint resolution shall be considered
16 as read. All points of order against provisions in the joint
17 resolution are waived. The previous question shall be con-
18 sidered as ordered on the joint resolution and on any
19 amendment thereto to final passage without intervening
20 motion except: (1) one hour of debate equally divided and
21 controlled by the chair and ranking minority member of
22 the Committee on Education and the Workforce or their
23 respective designees; and (2) one motion to recommit.

24 SEC. 3. Upon adoption of this resolution it shall be
25 in order to consider in the House the joint resolution (S.J.

1 Res. 38) providing for congressional disapproval under
2 chapter 8 of title 5, United States Code, of the rule sub-
3 mitted by the Federal Highway Administration relating to
4 “Waiver of Buy America Requirements for Electric Vehi-
5 cle Chargers”. All points of order against consideration
6 of the joint resolution are waived. The joint resolution
7 shall be considered as read. All points of order against
8 provisions in the joint resolution are waived. The previous
9 question shall be considered as ordered on the joint resolu-
10 tion and on any amendment thereto to final passage with-
11 out intervening motion except: (1) one hour of debate
12 equally divided and controlled by the chair and ranking
13 minority member of the Committee on Transportation and
14 Infrastructure or their respective designees; and (2) one
15 motion to commit.
