Mr. SCOTT of South Carolina (for himself and Mr. BOOKER) introduced the following bill; which was read twice and referred to the Committee on Health, Education, Labor, and Pensions

A BILL

To amend the Public Health Service Act to reauthorize a sickle cell disease prevention and treatment demonstration program.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Sickle Cell Disease
5 and Other Heritable Blood Disorders Research, Surveil-
6 lance, Prevention, and Treatment Act of 2023”.

1 **SEC. 2. SICKLE CELL DISEASE TREATMENT PREVENTION**
2 **AND TREATMENT.**

3 (a) IN GENERAL.—Section 1106(b) of the Public
4 Health Service Act (42 U.S.C. 300b–5(b)) is amended—

5 (1) in paragraph (1)(A)(iii), by striking “pre-
6 vention and treatment of sickle cell disease” and in-
7 serting “treatment of sickle cell disease and the pre-
8 vention and treatment of complications of sickle cell
9 disease”;

10 (2) in paragraph (2)(D), by striking “preven-
11 tion and treatment of sickle cell disease” and insert-
12 ing “treatment of sickle cell disease and the preven-
13 tion and treatment of complications of sickle cell dis-
14 ease”;

15 (3) in paragraph (3)—

16 (A) in subparagraph (A), by striking
17 “enter into a contract with” and inserting
18 “make a grant to, or enter into a contract or
19 cooperative agreement with,”; and

20 (B) in subparagraph (B), in each of
21 clauses (ii) and (iii), by striking “prevention
22 and treatment of sickle cell disease” and insert-
23 ing “treatment of sickle cell disease and the
24 prevention and treatment of complications of
25 sickle cell disease”; and

1 (4) in paragraph (6), by striking “\$4,455,000
2 for each of fiscal years 2019 through 2023” and in-
3 serting “\$8,205,000 for each of fiscal years 2024
4 through 2028”.

5 (b) SENSE OF CONGRESS.—It is the sense of Con-
6 gress that further research should be undertaken to ex-
7 pand the understanding of the causes of, and to find cures
8 for, heritable blood disorders, including sickle cell disease.
