## AN ACT

To amend the Taiwan Assurance Act of 2020 to require periodic reviews and updated reports relating to the Department of State's Taiwan Guidelines.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2       This Act may be cited as the “Taiwan Assurance Im-  
3 plementation Act”.

4 **SEC. 2. INCREASED REPORTING REGARDING DEPARTMENT**  
5 **OF STATE TAIWAN GUIDELINES.**

6       Section 315 of the Taiwan Assurance Act of 2020  
7 (subtitle B of title III of division FF of Public Law 116–  
8 260; 134 Stat. 3100) is amended—

9           (1) in subsection (c)(1), by inserting “and any  
10       successor document or related document that in-  
11       cludes guidance on relations with Taiwan” after  
12       “memorandum”; and

13           (2) by adding at the end the following new sub-  
14       section:

15       “(d) PERIODIC REVIEWS AND UPDATED REPORTS.—

16           “(1) IN GENERAL.—For as long as the Depart-  
17       ment of State maintains guidance that governs rela-  
18       tions with Taiwan as described in subsection (a), the  
19       Secretary of State shall—

20           “(A) not less than every five years, con-  
21       duct a review of the Department of State’s  
22       guidance that governs relations with Taiwan,  
23       including the periodic memorandum entitled,  
24       ‘Guidelines on Relations with Taiwan’ and re-  
25       lated documents, and reissue such guidance to  
26       executive branch departments and agencies; and

1           “(B) not later than 90 days after com-  
2           pleting a review required by paragraph (1)(A),  
3           submit an updated report to the Committee on  
4           Foreign Relations of the Senate and the Com-  
5           mittee on Foreign Affairs of the House of Rep-  
6           resentatives.

7           “(2) MATTERS TO BE INCLUDED.—The up-  
8           dated reports required under paragraph (1)(B) shall  
9           include—

10           “(A) all the information required under  
11           subsection (c); and

12           “(B) a description of how the updated  
13           guidance meets the goals and objectives de-  
14           scribed in subsection (b).”.
