#### AN ACT

- To amend title 38, United States Code, to promote assistance from persons recognized by the Secretary of Veterans Affairs for individuals who file certain claims under laws administered by the Secretary.

#### 1 SECTION 1. SHORT TITLE.

2	This Act may be cited as the "Veterans Claims Edu-
3	cation Act of 2025".
4	SEC. 2. PROMOTION OF ASSISTANCE FROM PERSONS REC-
5	OGNIZED BY THE SECRETARY OF VETERANS
6	AFFAIRS FOR INDIVIDUALS WHO FILE CER-
7	TAIN CLAIMS UNDER LAWS ADMINISTERED
8	BY THE SECRETARY.
9	(a) Notice to Claimants of Available Assist-
10	ANCE FROM RECOGNIZED PERSONS.—Section 5103A of
11	title 38, United States Code, is amended—
12	(1) by redesignating subsections (g) through (i)
13	as subsections (i) through (k), respectively;
14	(2) by inserting after subsection (f) the fol-
15	lowing new subsections:
16	"(g) Upon receipt of an initial claim by a claimant
17	not represented by an accredited person, the Secretary
18	shall provide notice to the claimant that—
19	"(1) an accredited person may be able to rep-
20	resent the claimant;
21	"(2) a veterans service organization recognized
22	under section 5902 of this title may represent the
23	claimant at no charge to the claimant;
24	"(3) provides the web address of the online tool
25	maintained under subsection (h); and

1	"(4) provides the web address of an appropriate
2	and publicly accessible website of the Department
3	through which a claimant may report—
4	"(A) a person, who is not an accredited
5	person, who represented the claimant; and
6	"(B) any fee charged by such person for
7	such representation.
8	"(h)(1) The Secretary shall maintain an online tool
9	that allows a claimant to search a list of accredited per-
10	sons who represent claimants.
11	"(2) The Secretary shall ensure that such list is cur-
12	rent at least once each calendar quarter.
13	"(3) The Secretary shall ensure that such tool is eas-
14	ily accessible to a claimant."; and
15	(3) by adding at the end the following new sub-
16	section:
17	"(l) In this section:
18	"(1) The term 'accredited person' means—
19	"(A) a veterans service organization recog-
20	nized under section 5902 of this title; or
21	"(B) an attorney, agent, or other person
22	recognized under section 5904 of this title.
23	"(2) The term 'represent' means to prepare,
24	present, or prosecute a claim under a law adminis-
25	tered by the Secretary on behalf of a claimant.".

1	(b) Online Information Regarding Persons
2	THAT ASSIST CLAIMANTS.—The Secretary of Veterans
3	Affairs shall include, in each web portal of the Department
4	of Veterans Affairs, through which an individual may file
5	a claim for a benefit administered by the Under Secretary
6	for Benefits or the Under Secretary for Health, a warning
7	regarding fees an agent or attorney may charge such indi-
8	vidual for assistance in filing such claim. Such warning
9	shall include the following:
10	(1) A link to the online tool maintained under
11	subsection (h) of section 5103A of such title, as
12	amended by subsection (a).
13	(2) A link to the website of the Department de-
14	scribed in subparagraph (D) of section $5103A(f)(1)$
15	of such title, as amended by subsection (a).
16	(c) Report.—Not later than 180 days after the date
17	of the enactment of this Act, the Secretary shall—
18	(1) complete a review the regulations, processes,
19	and procedures of the Department of Veterans Af-
20	fairs that pertain to recognition under section 5904
21	of title 38, United States Code;
22	(2) develop recommendations for legislative or
23	administrative action to improve such regulations,
24	processes, and procedures; and

1	(3) submit to the Committees on Veterans' Af-
2	fairs of the Senate and House of Representatives a
3	report containing the findings of the Secretary with
4	respect to the review completed under paragraph (1)
5	and the recommendations developed under para-
6	graph (2).
