A BILL

To expand and modify the grant program of the Department of Veterans Affairs to provide innovative transportation options to veterans in highly rural areas, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Rural Veterans Trans-
5 portation to Care Act”.

1 **SEC. 2. EXPANSION AND MODIFICATION OF TRANSPOR-**
2 **TATION GRANT PROGRAM OF DEPARTMENT**
3 **OF VETERANS AFFAIRS.**

4 Section 307 of the Caregivers and Veterans Omnibus
5 Health Services Act of 2010 (Public Law 111–163; 38
6 U.S.C. 1710 note) is amended—

7 (1) in the section heading, by inserting
8 **“RURAL OR”** before **“HIGHLY”**;

9 (2) in subsection (a)—

10 (A) by inserting “rural or” before “highly”
11 each place it appears;

12 (B) in paragraph (2)—

13 (i) by redesignating subparagraph (B)
14 as subparagraph (C);

15 (ii) by inserting after subparagraph

16 (A) the following new subparagraph (B):

17 “(B) County veterans service organiza-
18 tions.”; and

19 (iii) by adding at the end the fol-
20 lowing new subparagraph:

21 “(D) Tribal organizations.”;

22 (C) in paragraph (3), by striking “A State
23 veterans service agency or veterans service or-
24 ganization awarded” and inserting “A recipient
25 of”; and

1 (D) by striking paragraph (4) and insert-
 2 ing the following new paragraph (4):

3 “(4) MAXIMUM AMOUNT.—

4 “(A) IN GENERAL.—Except as provided in
 5 subparagraph (B), the amount of a grant under
 6 this section may not exceed \$60,000.

7 “(B) ADDITIONAL AMOUNT TO PURCHASE
 8 A VEHICLE.—The amount of a grant under this
 9 section to a recipient may be increased to an
 10 amount not to exceed \$80,000 if the recipient
 11 is required to purchase a vehicle to comply with
 12 the requirements of the Americans with Disabil-
 13 ities Act of 1990 (42 U.S.C. 12101 et seq.) in
 14 carrying out this section.”;

15 (3) in subsection (c), by striking paragraph (1)
 16 and inserting the following:

17 “(1) RURAL; HIGHLY RURAL.—The terms
 18 ‘rural’ and ‘highly rural’ have the meanings given
 19 those terms under the Rural-Urban Commuting
 20 Areas (RUCA) coding system of the Department of
 21 Agriculture.”; and

22 (4) in subsection (d), by striking “\$3,000,000
 23 for each of fiscal years 2010 through 2022” and in-
 24 serting “such sums as may be necessary”.
