# H. R. 1766

## AN ACT

To amend the National Telecommunications and Information Administration Organization Act to establish the Office of Policy Development and Cybersecurity, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2   *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2       This Act may be cited as the “NTIA Policy and Cy-  
3 bersecurity Coordination Act”.

4 **SEC. 2. POLICY DEVELOPMENT AND CYBERSECURITY.**

5       (a) OFFICE OF POLICY DEVELOPMENT AND CYBER-  
6 SECURITY.—Part A of the National Telecommunications  
7 and Information Administration Organization Act (47  
8 U.S.C. 901 et seq.) is amended by adding at the end the  
9 following:

10 **“SEC. 106. OFFICE OF POLICY DEVELOPMENT AND CYBER-**  
11 **SECURITY.**

12       “(a) ESTABLISHMENT.—There shall be within the  
13 NTIA an office to be known as the Office of Policy Devel-  
14 opment and Cybersecurity (in this section referred to as  
15 the ‘Office’).

16       “(b) ASSOCIATE ADMINISTRATOR.—The head of the  
17 Office shall be an Associate Administrator for Policy De-  
18 velopment and Cybersecurity (in this section referred to  
19 as the ‘Associate Administrator’), who shall report to the  
20 Assistant Secretary.

21       “(c) DUTIES.—

22               “(1) IN GENERAL.—The Associate Adminis-  
23 trator shall oversee and conduct national commu-  
24 nications and information policy analysis and devel-  
25 opment for the internet and communications tech-  
26 nologies.

1           “(2) PARTICULAR DUTIES.—In carrying out  
2 paragraph (1), the Associate Administrator shall—

3           “(A) develop, analyze, and advocate for  
4 market-based policies that promote innovation,  
5 competition, consumer access, digital inclusion,  
6 workforce development, and economic growth in  
7 the communications, media, and technology  
8 markets;

9           “(B) conduct studies, as delegated by the  
10 Assistant Secretary or required by Congress, on  
11 how individuals in the United States access and  
12 use the internet, wireline and wireless teleph-  
13 ony, mass media, other digital services, and  
14 video services;

15           “(C) coordinate transparent, consensus-  
16 based, multistakeholder processes to create  
17 guidance for and to support the development  
18 and implementation of cybersecurity and pri-  
19 vacy policies with respect to the internet and  
20 other communications networks;

21           “(D) promote increased collaboration be-  
22 tween security researchers and providers of  
23 communications services and software system  
24 developers;

1           “(E) perform such duties as the Assistant  
2           Secretary considers appropriate relating to the  
3           program for preventing future vulnerabilities es-  
4           tablished under section 8(a) of the Secure and  
5           Trusted Communications Networks Act of 2019  
6           (47 U.S.C. 1607(a));

7           “(F) advocate for policies that promote the  
8           security and resilience to cybersecurity incidents  
9           of communications networks while fostering in-  
10          novation, including policies that promote secure  
11          communications network supply chains;

12          “(G) at the direction of the Assistant Sec-  
13          retary, present security of the digital economy  
14          and infrastructure and cybersecurity policy ef-  
15          forts before the Commission, Congress, and  
16          elsewhere;

17          “(H) provide advice and assistance to the  
18          Assistant Secretary in carrying out the policy  
19          responsibilities of the NTIA with respect to cy-  
20          bersecurity policy matters, including the evalua-  
21          tion of the impact of cybersecurity matters  
22          pending before the Commission, other Federal  
23          agencies, and Congress;

24          “(I) in addition to the duties described in  
25          subparagraph (H), perform such other duties

1           regarding the policy responsibilities of the  
2           NTIA with respect to cybersecurity policy mat-  
3           ters as the Assistant Secretary considers appro-  
4           priate;

5           “(J) develop policies to accelerate innova-  
6           tion and commercialization with respect to ad-  
7           vances in technological understanding of com-  
8           munications technologies;

9           “(K) identify barriers to trust, security, in-  
10          novation, and commercialization with respect to  
11          communications technologies, including access  
12          to capital and other resources, and ways to  
13          overcome such barriers;

14          “(L) provide public access to relevant data,  
15          research, and technical assistance on innovation  
16          and commercialization with respect to commu-  
17          nications technologies, consistent with the pro-  
18          tection of classified information;

19          “(M) strengthen collaboration on and co-  
20          ordination of policies relating to innovation and  
21          commercialization with respect to communica-  
22          tions technologies, including policies focused on  
23          the needs of small businesses and rural commu-  
24          nities—

1 “(i) within the Department of Com-  
2 merce;

3 “(ii) between the Department of Com-  
4 merce and State government agencies, as  
5 appropriate; and

6 “(iii) between the Department of  
7 Commerce and the Commission or any  
8 other Federal agency the Assistant Sec-  
9 retary determines to be necessary; and

10 “(N) solicit and consider feedback from  
11 small and rural communications service pro-  
12 viders, as appropriate.”.

13 (b) TRANSITIONAL RULES.—

14 (1) REDESIGNATION OF ASSOCIATE ADMINIS-  
15 TRATOR; CONTINUATION OF SERVICE.—

16 (A) REDESIGNATION.—The position of As-  
17 sociate Administrator for Policy Analysis and  
18 Development at the NTIA is hereby redesign-  
19 ated as the position of Associate Adminis-  
20 trator for Policy Development and Cybersecu-  
21 rity.

22 (B) CONTINUATION OF SERVICE.—The in-  
23 dividual serving as Associate Administrator for  
24 Policy Analysis and Development at the NTIA  
25 on the date of the enactment of this Act shall

1           become, as of such date, the Associate Adminis-  
2           trator for Policy Development and Cybersecu-  
3           rity.

4           (2) NTIA DEFINED.—In this subsection, the  
5           term “NTIA” means the National Telecommuni-  
6           cations and Information Administration.
