AN ACT

To reauthorize the Adams Memorial Commission, and for
other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Adams Memorial-Great
3 American Heroes Act”.

4 **SEC. 2. EXTENSION OF AUTHORITY; LOCATION OF MEMO-**
5 **RIAL.**

6 (a) ADAMS MEMORIAL COMMISSION.—

7 (1) EXTENSION.—Section 2406(l) of the John
8 D. Dingell, Jr. Conservation, Management, and
9 Recreation Act (Public Law 116–9) is amended by
10 striking “2025” and inserting “2032”.

11 (2) EFFECTIVE DATE.—The amendment made
12 by paragraph (1) shall take effect as if enacted on
13 December 1, 2025.

14 (b) COMPLIANCE WITH STANDARDS FOR COMMEMO-
15 RATIVE WORKS.—Section 1(c) of Public Law 107–62 (115
16 Stat. 411; 124 Stat. 1192; 127 Stat. 3880; 133 Stat. 750)
17 is amended—

18 (1) by striking “The establishment” and insert-
19 ing “Notwithstanding section 8908(c) of title 40,
20 United States Code, the establishment”; and

21 (2) by striking “2025” and inserting “2032”.

22 (c) LOCATION OF COMMEMORATIVE WORK.—Section
23 1 of Public Law 107–315 (116 Stat. 2763) is amended
24 to read as follows:

1 **“SEC. 1. APPROVAL OF COMMEMORATIVE WORK.**

2 “(a) SITE.—Notwithstanding section 8908(c) of title
3 40, United States Code, and subject to subsection (b), the
4 Adams Memorial shall be located within the area generally
5 depicted as ‘Adams Memorial: Eligible Additional Area’ on
6 the map titled ‘Adams Memorial: Eligible Additional Area’
7 prepared by the Adams Memorial Commission and dated
8 February 25, 2025.

9 “(b) ADDITIONAL LOCATIONS.—If the Commission
10 determines that the location described in subsection (a)
11 is not suitable or feasible due to physical or security con-
12 straints, the commemorative work shall be located within
13 the Reserve.

14 “(c) DEFINITIONS.—In this section:

15 “(1) ADAMS MEMORIAL.—The term ‘Adams
16 Memorial’ means the commemorative work author-
17 ized to be established under section 1(b) of Public
18 Law 107–62 (115 Stat. 411).

19 “(2) COMMISSION.—The term ‘Commission’
20 means the Adams Memorial Commission established
21 under section 2406(a) of the John D. Dingell, Jr.
22 Conservation, Management, and Recreation Act
23 (Public Law 116–9).

24 “(3) RESERVE.—The term ‘Reserve’ has the
25 meaning given such term in section 8902(a)(3) of
26 title 40, United States Code.”.

1 SEC. 3. CONFORMING AMENDMENTS.

2 Section 2 and section 3 of Public Law 107–315 (116
3 Stat. 2763) are hereby repealed.
