## A BILL

To modernize permitting systems at the Department of the  
Interior, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Electronic Permitting  
5       Modernization Act”.

6       **SEC. 2. DEPARTMENT OF THE INTERIOR PERMIT ACCESSI-**  
7       **BILITY.**

8       (a) IN GENERAL.—In order to improve the overall  
9       economy, efficiency, and management of operations and  
10      activities of the Department of the Interior (referred to

1 in this section as the “Department”), reduce paperwork,  
2 and provide high-quality services and access to the public,  
3 the Secretary of the Interior shall, to the extent prac-  
4 ticable—

5 (1) design and deliver modernized electronic  
6 permitting systems to accept, process, and record  
7 applications (including plan submissions, payment  
8 activity, and other related correspondence) for per-  
9 mits, forms, and other paperwork required for activi-  
10 ties regulated by the Department;

11 (2) provide a centralized electronic permitting  
12 system online repository, available to the public on  
13 the Department’s website, that includes—

14 (A) hyperlinks to facilitate navigation to  
15 all Department electronic permitting systems;  
16 and

17 (B) with respect to permits, the contact in-  
18 formation for the appropriate Department em-  
19 ployees providing assistance to State, Tribal,  
20 and local governments; and

21 (3) provide to the Committee on Natural Re-  
22 sources of the House of Representatives and the  
23 Committee on Energy and Natural Resources of the  
24 Senate periodic updates on the implementation of  
25 paragraphs (1) and (2).

1 (b) DISCLOSURE OF INFORMATION PROHIBITED.—  
 2 No information described in section 552(b) of title 5,  
 3 United States Code, or protected from disclosure by an-  
 4 other law of the United States shall be disclosed under  
 5 this Act.

6 (c) DUPLICATION OF SYSTEMS NOT PERMITTED.—  
 7 No system shall be duplicated under this Act.

8 (d) CONSULTATION.—In developing the permitting  
 9 systems required under section 2 of this Act, the Secretary  
 10 of the Interior shall consult with States, local govern-  
 11 ments, Indian Tribes and other stakeholders who apply  
 12 for agency permits and will use the permitting systems.

13 **SEC. 3. CONFORMING AMENDMENT TO ENSURE CONSIST-**  
 14 **ENCY WITH THE FISCAL RESPONSIBILITY**  
 15 **ACT OF 2023.**

16 In developing the permitting systems required under  
 17 section 2 of this Act, the Secretary of the Interior shall  
 18 ensure that the Department's electronic permitting sys-  
 19 tems are consistent with the priorities identified in section  
 20 110 of the National Environmental Policy Act of 1969 (42  
 21 U.S.C. 4336d) with respect to any permit that requires  
 22 review under that Act.
