A BILL

To direct the Secretary of Health and Human Services to conduct a review to evaluate the status of research on lung cancer in women and underserved populations, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Women and Lung Can-
5 cer Research and Preventive Services Act of 2025”.

1 **SEC. 2. INTERAGENCY REVIEW TO EVALUATE AND IDEN-**
2 **TIFY OPPORTUNITIES FOR THE ACCELERA-**
3 **TION OF RESEARCH ON LUNG CANCER IN**
4 **WOMEN AND UNDERSERVED POPULATIONS,**
5 **GREATER ACCESS TO PREVENTIVE SERV-**
6 **ICES, AND STRATEGIC PUBLIC AWARENESS**
7 **AND EDUCATION CAMPAIGNS.**

8 (a) IN GENERAL.—The Secretary of Health and
9 Human Services, in consultation with the Secretary of De-
10 fense and the Secretary of Veterans Affairs, shall conduct
11 an interagency review to evaluate the status of, and iden-
12 tify opportunities for the acceleration of research related
13 to—

- 14 (1) research on lung cancer in women;
15 (2) research on lung cancer in underserved pop-
16 ulations that meet the eligibility criteria for lung
17 cancer screening as recommended by the United
18 States Preventive Services Task Force;
19 (3) access to lung cancer preventive services;
20 and
21 (4) strategic public awareness and education
22 campaigns on lung cancer.

23 (b) CONTENT.—The review and recommendations
24 under subsection (a) shall include—

- 25 (1) a review and comprehensive report on the
26 outcomes of previous research, the status of existing

1 research activities, and knowledge gaps related to
2 lung cancer in women and underserved populations
3 in all agencies of the Federal Government;

4 (2) opportunities for collaborative, interagency,
5 multidisciplinary, and innovative research, that
6 would—

7 (A) encourage innovative approaches to
8 eliminate knowledge gaps in research on lung
9 cancer in women;

10 (B) evaluate environmental and genomic
11 factors that may be related to the etiology of
12 lung cancer in women; and

13 (C) foster advances in imaging technology
14 and techniques to improve risk assessment, di-
15 agnosis, treatment, and the simultaneous utili-
16 zation of other preventive services and activi-
17 ties;

18 (3) opportunities regarding the development of
19 a national lung cancer screening strategy to expand
20 access to such screenings, particularly among women
21 and underserved populations; and

22 (4) opportunities regarding the development of
23 a national public education and awareness campaign
24 on—

1 (A) lung cancer in women and underserved
2 populations; and

3 (B) the importance of early detection of
4 lung cancer.

5 (c) REPORT.—Not later than two years after the date
6 of the enactment of this Act, the Secretary of Health and
7 Human Services shall submit to Congress a report on the
8 review conducted under subsection (a).
