# **A BILL**

To amend title 46, United States Code, to prohibit certain contracts for port operations and management, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Secure Our Ports Act*  
 5 *of 2025”.*

6 **SEC. 2. PROHIBITION ON CERTAIN CONTRACTS FOR PORT**  
 7 **OPERATION AND MANAGEMENT.**

8 *(a) IN GENERAL.—Subchapter II of chapter 700 of*  
 9 *title 46, United States Code, is amended by adding at the*  
 10 *end the following:*

11 **“§ 70015. Prohibition on certain contracts for port op-**  
 12 **eration and management**

13 *“(a) IN GENERAL.—An owner or operator of a facility*  
 14 *for which a facility security plan is required under section*  
 15 *70103(c) of this title may not enter into a contract for the*  
 16 *ownership, leasing, or operation of such facility with an*  
 17 *entity that is—*

18 *“(1) a Chinese, Russian, North Korean, or Ira-*  
 19 *nian state-owned enterprise; or*

20 *“(2) a foreign entity for which any percentage is*  
 21 *owned by a country listed in paragraph (1).*

22 *“(b) DEFINITIONS.—In this section, the terms ‘facil-*  
 23 *ity’, and ‘owner or operator’ have the meanings given such*  
 24 *terms in section 70101 of this title.”.*

1           **(b) CLERICAL AMENDMENT.**—*The analysis for chapter*  
2 *700 of title 46, United States Code, is amended by inserting*  
3 *after the item relating to section 70014 the following:*

*“70015. Prohibition on certain contracts for port operation and management.”.*
