A BILL

To require public elementary and middle schools that receive funds under the Elementary and Secondary Education Act of 1965 to obtain parental consent before changing a minor's gender markers, pronouns, or preferred name on any school form or sex-based accommodations, including locker rooms or bathrooms.

 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Parental Rights Over*
 5 *The Education and Care of Their Kids Act” or the “PRO-*
 6 *TECT Kids Act”.*

7 **SEC. 2. PARENTAL CONSENT REQUIREMENT RELATED TO**
 8 **GENDER MARKERS, PRONOUNS, AND PRE-**
 9 **FERRED NAMES ON SCHOOL FORMS AND SEX-**
 10 **BASED ACCOMMODATIONS.**

11 *(a) REQUIREMENT.—As a condition of receiving funds*
 12 *under the Elementary and Secondary Education Act of*
 13 *1965 (20 U.S.C. 6301 et seq.), a public school that receives*
 14 *funds under such Act shall obtain parental consent before*
 15 *changing a covered student’s—*

16 *(1) gender markers, pronouns, or preferred name*
 17 *on any school form; or*

18 *(2) sex-based accommodations, including locker*
 19 *rooms or bathrooms.*

20 *(b) DEFINITIONS.—In this section:*

21 *(1) COVERED STUDENT.—The term “covered stu-*
 22 *dent” means a minor who is—*

23 *(A) an elementary school student; or*

24 *(B) a student in any of the middle grades.*

1 (2) *ESEA TERMS*.—*The terms “elementary*
2 *school”, “middle grades”, and “parent” have the*
3 *meanings given such terms in section 8101 of the Ele-*
4 *mentary and Secondary Education Act of 1965 (20*
5 *U.S.C. 7801).*
