# **A BILL**

To direct the Secretary of Veterans Affairs to establish and carry out a pilot program to furnish a headstone or burial marker to veterans who died on or before November 1, 1990, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
 2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       *This Act may be cited as the “Honoring Our Heroes*  
 5       *Act of 2025”.*

6       **SEC. 2. TEMPORARY AUTHORITY TO FURNISH HEADSTONES**  
 7               **AND BURIAL MARKERS TO CERTAIN VET-**  
 8               **ERANS.**

9       (a) *AUTHORITY.*—*During the period of seven years fol-*  
 10       *lowing the date of the enactment of this Act, the Secretary*  
 11       *of Veterans Affairs shall furnish, pursuant to section 2306*  
 12       *of title 38, United States Code, and without regards to sec-*  
 13       *tion 8041(b) of the Omnibus Budget Reconciliation Act of*  
 14       *1990 (Public Law 101–508), an appropriate headstone,*  
 15       *burial marker, or medallion for a veteran—*

16               (1) *eligible for burial in a national cemetery;*  
 17               (2) *who died on or after December 7, 1941; and*  
 18               (3) *for whose grave the Secretary has not already*  
 19       *provided a headstone, burial marker, or medallion.*

20       (b) *WEBSITE.*—*During such period, the Secretary*  
 21       *shall ensure that the website of the National Cemetery Ad-*  
 22       *ministration indicates the effect of this Act on eligibility*  
 23       *for a headstone, burial marker, or medallion under such*  
 24       *section.*

1 **SEC. 3. EXTENSION OF CERTAIN LIMITS ON PAYMENTS OF**  
2 **PENSION.**

3 *Section 5503(d)(7) of title 38, United States Code, is*  
4 *amended by striking “November 30, 2031” and inserting*  
5 *“February 29, 2032”.*
