A BILL

To amend the Congressional Budget Act of 1974 to provide for a point of order against reconciliation measures that cut benefits for Medicaid or the Supplemental Nutrition Assistance Program, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Hands Off Medicaid
5 and SNAP Act of 2025”.

1 **SEC. 2. RECONCILIATION POINT OF ORDER ON CUTS TO**
2 **CERTAIN PROGRAMS.**

3 (a) IN GENERAL.—Section 310 of the Congressional
4 Budget Act of 1974 (2 U.S.C. 641) is amended by adding
5 at the end the following:

6 “(h) LIMITATION ON CUTS TO CERTAIN PRO-
7 GRAMS.—Notwithstanding any other provision of law, it
8 shall not be in order in the Senate or the House of Rep-
9 resentatives to consider any reconciliation bill or reconcili-
10 ation resolution reported pursuant to a concurrent resolu-
11 tion on the budget agreed to under section 301 or 304,
12 or a joint resolution pursuant to section 258C of the Bal-
13 anced Budget and Emergency Deficit Control Act of 1985,
14 or any amendment thereto or conference report thereon
15 that—

16 “(1) reduces enrollment or benefits for individ-
17 uals enrolled in the Medicaid program under title
18 XIX of the Social Security Act; or

19 “(2) reduces eligibility or benefits for house-
20 holds that participate in the supplemental nutrition
21 assistance program under the Food and Nutrition
22 Act of 2008.

23 “(i) EXPIRATION OF LIMITATION ON CUTS TO CER-
24 TAIN PROGRAMS.—Subsection (h) shall expire on January
25 20, 2029.”.

1 (b) CONFORMING AMENDMENT.—Section 313(b)(1)
2 of the Congressional Budget Act of 1974 (2 U.S.C. 644)
3 is amended by striking the period at the end and inserting
4 “or, until January 20, 2029, if it violates section 310(h).”.
