# **A BILL**

To rename the Gulf of Mexico as the “Gulf of America”.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       *This Act may be cited as the “Gulf of America Act”.*

5       **SEC. 2. RENAMING OF GULF OF MEXICO AS “GULF OF AMER-**  
6                       **ICA”.**

7       *(a) RENAMING.—The Gulf of Mexico shall be known*  
8       *as the “Gulf of America”.*

9       *(b) REFERENCES.—Any reference in a law, map, regu-*  
10       *lation, document, paper, or other record of the United*  
11       *States to the Gulf of Mexico shall be deemed to be a reference*  
12       *to the “Gulf of America”.*

13       *(c) IMPLEMENTATION.—*

14               *(1) IN GENERAL.—The Secretary of the Interior,*  
15       *acting through the Chairman of the Board on Geo-*  
16       *graphic Names, shall oversee the implementation of*  
17       *the renaming described in subsection (a) with respect*  
18       *to each Federal document and map.*

19               *(2) REQUIREMENT.—Not later than 180 days*  
20       *after the date of the enactment of this section, the*  
21       *head of each Federal agency shall update each docu-*  
22       *ment and map of the Federal agency in accordance*  
23       *with the renaming described in subsection (a).*
