A BILL

To provide equitable treatment for the people of the Village Corporation established for the Native Village of Saxman, Alaska, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Cape Fox Land Entitle-*
 5 *ment Finalization Act of 2025”.*

6 **SEC. 2. DEFINITIONS.**

7 *In this Act:*

8 (1) *CAPE FOX.*—*The term “Cape Fox” means the*
 9 *Cape Fox Village Corporation, a Village Corporation*
 10 *for the Native Village of Saxman, Alaska, organized*
 11 *pursuant to the Alaska Native Claims Settlement Act*
 12 *(43 U.S.C. 1601 et seq.).*

13 (2) *FEDERAL LAND.*—*The term “Federal land”*
 14 *means the approximately 180 acres of surface land*
 15 *within the Tongass National Forest in the State of*
 16 *Alaska, as generally depicted on the Map.*

17 (3) *MAP.*—*The term “Map” means the map enti-*
 18 *tled “Cape Fox Village Corporation Final Selection”*
 19 *and dated December 18, 2023.*

20 (4) *SECRETARY.*—*The term “Secretary” means*
 21 *the Secretary of the Interior.*

22 **SEC. 3. WAIVER OF CORE TOWNSHIP REQUIREMENT FOR**
 23 **CERTAIN LAND.**

24 (a) *IN GENERAL.*—*Notwithstanding section 16(b) of*
 25 *the Alaska Native Claims Settlement Act (43 U.S.C.*

1 1615(b)), *Cape Fox shall not be required to select or receive*
 2 *conveyance of the approximately 185 acres of unconveyed*
 3 *land described in subsection (b) located within the township*
 4 *in which the Native Village of Saxman, Alaska, is located.*

5 (b) *LAND DESCRIBED.*—*The land referred to in sub-*
 6 *section (a) is as follows:*

7 (1) *Approximately 40 acres in T. 74 S., R.90 E.,*
 8 *sec. 10, SWNE, Copper River Meridian.*

9 (2) *Approximately 144.57 acres in T. 75 S.,*
 10 *R.91 E., sec. 1, lots 1, 3, and 4, Copper River Merid-*
 11 *ian.*

12 **SEC. 4. SELECTION OUTSIDE EXTERIOR SELECTION**
 13 **BOUNDARY.**

14 (a) *SELECTION AND CONVEYANCE OF SURFACE ES-*
 15 *TATE.*—*Not later than 90 days after the date of enactment*
 16 *of this Act, if Cape Fox submits to the Secretary a written*
 17 *notice of selection of the Federal land, the Secretary shall,*
 18 *on receiving that written notice, convey the Federal land*
 19 *to Cape Fox.*

20 (b) *CONVEYANCE OF SUBSURFACE ESTATE.*—*On con-*
 21 *veyance to Cape Fox of the surface estate to the Federal*
 22 *land under subsection (a), the Secretary shall convey to*
 23 *Sealaska Corporation the subsurface estate to that Federal*
 24 *land.*

1 (c) *TIMING.*—*It is the intent of Congress that the Sec-*
 2 *retary complete the conveyances to Cape Fox and Sealaska*
 3 *Corporation under subsections (a) and (b), respectively, as*
 4 *soon as practicable after the date on which the Secretary*
 5 *receives a written notice of the selection of Cape Fox under*
 6 *subsection (a), but not later than 180 days after the date*
 7 *on which the Secretary receives that written notice.*

8 (d) *ENTITLEMENT FULFILLED.*—*The conveyance of*
 9 *Federal land to Cape Fox and the subsurface interest in*
 10 *the Federal land to Sealaska Corporation under subsections*
 11 *(a) and (b), respectively, shall be considered to fulfill the*
 12 *entitlement of—*

13 (1) *Cape Fox under section 16 of the Alaska Na-*
 14 *tive Claims Settlement Act (43 U.S.C. 1615); and*

15 (2) *Sealaska Corporation to any subsurface in-*
 16 *terest in the Federal land under section 14(f) of that*
 17 *Act (43 U.S.C. 1613(f)).*

18 **SEC. 5. PUBLIC ACCESS EASEMENT.**

19 *The conveyance of the Federal land under section 4*
 20 *shall be subject to the reservation of a public easement under*
 21 *section 17(b) of the Alaska Native Claims Settlement Act*
 22 *(43 U.S.C. 1616(b)) to allow for access to National Forest*
 23 *System land further inland on Revillagigedo Island from*
 24 *the George Inlet.*

1 **SEC. 6. VALID EXISTING RIGHTS.**

2 *Unless otherwise agreed to by the Secretary, the Sec-*
3 *retary of Agriculture, and Cape Fox, the conveyances under*
4 *this legislation shall be subject to any valid existing rights,*
5 *reservations, rights-of-way, and other encumbrances of third*
6 *parties in, to, or on the Federal land as of the date of enact-*
7 *ment of this Act.*
