A BILL

To amend title 38, United States Code, to authorize the Secretary of Veterans Affairs to approve multi-State apprenticeship programs for purposes of veterans educational assistance, and for other purposes.

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Veterans’ Transition to*
 5 *Trucking Act of 2025”.*

13 *Section 3672(c)(1) of title 38, United States Code, is*
 14 *amended—*

15 (1) *by redesignating subparagraph (B) as sub-*
 16 *paragraph (C);*

17 (2) *in subparagraph (A), in the matter before*
 18 *clause (i), by striking “The State” and inserting “Ex-*
 19 *cept as provided in subparagraph (B), the State”;*
 20 *and*

21 (3) *by inserting after subparagraph (A) the fol-*
 22 *lowing new subparagraph (B):*

23 *“(B) The Secretary may act in the role of a State ap-*
 24 *proving agency for purposes of approval of a multi-State*

- 1 *apprenticeship program provided by a commercial truck*
- 2 *driving school.”.*

Amend the title so as to read: “A bill to amend title 38, United States Code, to authorize the Secretary of Veterans Affairs to approve multi-State apprenticeship programs provided by commercial truck driving schools for purposes of Department of Veterans Affairs educational assistance programs, and for other purposes.”.
