Ms. TENNEY introduced the following bill; which was referred to the Committee on the Judiciary

A BILL

To provide that jurisdictions with law enforcement cooperation restrictions are ineligible for certain Federal funds, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Law Enforcement Soli-
5 darity Act”.

6 **SEC. 2. JURISDICTIONS WITH LAW ENFORCEMENT CO-**
7 **OPERATION RESTRICTIONS INELIGIBLE FOR**
8 **CERTAIN FEDERAL FUNDS.**

9 Beginning in the first fiscal year that begins after
10 the date that is 60 days after the date of enactment of

1 this Act, for a fiscal year during which the Attorney Gen-
2 eral determines that a jurisdiction is a jurisdiction with
3 law enforcement cooperation restrictions, such jurisdiction
4 is ineligible to receive any Federal funds that such juris-
5 diction intends to use for the benefit (including the provi-
6 sion of food, shelter, healthcare services, legal services,
7 and transportation) of aliens who are present in the
8 United States without lawful status under the immigration
9 laws.

10 **SEC. 3. REPORT ON JURISDICTION WITH LAW ENFORCE-**
11 **MENT COOPERATION RESTRICTIONS.**

12 Not later than 1 year after the date of enactment
13 of this Act, and annually thereafter, the Attorney General
14 shall submit to the Committee on the Judiciary of the
15 House of Representatives and the Committee on the Judi-
16 ciary of the Senate a report that includes a list of each
17 jurisdiction that the Attorney General determines is a ju-
18 risdiction with law enforcement cooperation restrictions.

19 **SEC. 4. DEFINITIONS.**

20 For purposes of this Act:

21 (1) the term “jurisdiction with law enforcement
22 cooperation restrictions” means any State or polit-
23 ical subdivision of a State that has in effect a stat-
24 ute, ordinance, policy, or practice that prohibits or
25 restricts any government entity or official from as-

1 sisting, aiding, cooperating with, providing back-up
2 to, or responding to a call made by a Federal law
3 enforcement officer.

4 (2) The terms “alien” and “immigration laws”
5 have the meanings given such term in section 101
6 of the Immigration and Nationality Act (8 U.S.C.
7 1101).

8 (3) The term “Federal law enforcement officer”
9 has the meaning given such term in section
10 115(c)(1) of title 18, United States Code, and in-
11 cludes such an officer employed by the Department
12 of Homeland Security.
