## A BILL

To amend title 38, United States Code, to increase the amount paid by the Secretary of Veterans Affairs to veterans for improvements and structural alterations furnished as part of home health services.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Autonomy for All Dis-  
5       abled Veterans Act”.

1 **SEC. 2. INCREASE IN AMOUNT AVAILABLE TO DISABLED**  
2 **VETERANS FOR IMPROVEMENTS AND STRUC-**  
3 **TURAL ALTERATIONS FURNISHED AS PART**  
4 **OF HOME HEALTH SERVICES.**

5 (a) INCREASE.—Paragraph (2) of section 1717(a) of  
6 title 38, United States Code, is amended—

7 (1) in subparagraph (A)(ii), by striking  
8 “\$6,800” and inserting “\$10,000”; and

9 (2) in subparagraph (B)(ii), by striking  
10 “\$2,000” and inserting “\$10,000”.

11 (b) EFFECTIVE DATE.—The amendments made by  
12 subsection (a) shall apply with respect to a veteran who  
13 first applies for benefits under section 1717(a)(2) of title  
14 38, United States Code, on or after the date of the enact-  
15 ment of this Act.

16 (c) APPLICABILITY.—A veteran who exhausts such  
17 veteran’s eligibility for benefits under section 1717(a)(2)  
18 of title 38, United States Code, before the date of the en-  
19 actment of this Act, is not entitled to additional benefits  
20 under such section by reason of the amendments made  
21 by subsection (a).

22 **SEC. 3. ADJUSTMENT FOR INFLATION.**

23 Section 1717(a) of title 38, United States Code, is  
24 further amended by adding at the end the following:

25 “(4) Except as provided in subparagraph (B), on the  
26 first day of each fiscal year, the Secretary shall increase

1 the dollar amounts in effect under subsection (a)(2) by  
2 a percentage equal to the percentage by which the residen-  
3 tial home cost of construction index established under sec-  
4 tion 2102(e)(3) of this title increased during the previous  
5 fiscal year. In the event that such index does not increase  
6 during such period, the Secretary shall maintain the dollar  
7 amount in effect under subsection (a)(2) during the pre-  
8 vious fiscal year.”.
