## A BILL

To amend the Public Health Service Act to expand and improve health care services by health centers and the National Health Service Corps for individuals with a developmental disability, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Healthcare Extension  
5       and Accessibility for Developmentally disabled and Under-  
6       served Population Act of 2025” or the “HEADs UP Act  
7       of 2025”.

1 **SEC. 2. HEALTH CARE SERVICES BY HEALTH CENTERS AND**  
2 **NATIONAL HEALTH SERVICE CORPS FOR IN-**  
3 **DIVIDUALS WITH A DEVELOPMENTAL DIS-**  
4 **ABILITY.**

5 (a) INCLUSION WITHIN SPECIAL MEDICALLY UN-  
6 DERSERVED POPULATIONS FOR PURPOSES OF HEALTH  
7 CENTER DEFINITION.—Section 330(a)(1) of the Public  
8 Health Service Act (42 U.S.C. 254b(a)(1)) is amended by  
9 striking “and residents of public housing,” and inserting  
10 “residents of public housing, and individuals with a devel-  
11 opmental disability”.

12 (b) DEFINITION.—Section 330(b) of the Public  
13 Health Service Act (42 U.S.C. 254b(a)(1)) is amended by  
14 adding at the end the following:

15 “(4) INDIVIDUALS WITH A DEVELOPMENTAL  
16 DISABILITY.—In this section, the term ‘individuals  
17 with a developmental disability’ means individuals  
18 with a developmental disability as defined in section  
19 102 of the Developmental Disabilities Assistance  
20 and Bill of Rights Act of 2000.”.

21 (c) GRANTS FOR SERVICES.—

22 (1) AUTHORIZATION.—Section 330 of the Pub-  
23 lic Health Service Act (42 U.S.C. 254b) is amend-  
24 ed—

1 (A) by redesignating subsections (j)  
2 through (r) as subsections (k) through (s), re-  
3 spectively; and

4 (B) by inserting after subsection (i) the  
5 following:

6 “(j) INDIVIDUALS WITH A DEVELOPMENTAL DIS-  
7 ABILITY.—

8 “(1) IN GENERAL.—The Secretary may award  
9 grants to existing health centers for the purposes de-  
10 scribed in subsections (e) and (f) to establish or op-  
11 erate new delivery sites for comprehensive primary  
12 health services, including dental care, to a special  
13 medically underserved population comprised of indi-  
14 viduals with a developmental disability.

15 “(2) REQUIRED SERVICES.—In addition to re-  
16 quired primary health services (as defined in sub-  
17 section (b)(1)), an entity that receives a grant under  
18 this subsection shall be required to provide special-  
19 ized treatment, as necessary, including specially  
20 trained dental care services, to individuals with a de-  
21 velopmental disability as a condition of such grant.

22 “(3) SUPPLEMENT NOT SUPPLANT REQUIRE-  
23 MENT.—A grant awarded under this subsection shall  
24 be expended to supplement, and not supplant, the  
25 expenditures of the health center and the value of in

1 kind contributions for the delivery of services to the  
2 population described in paragraph (1).”.

3 (2) CONFORMING CHANGE.—Section 330(a)(2)  
4 of the Public Health Service Act (42 U.S.C.  
5 254b(a)(2)) is amended by striking “or (i)” and in-  
6 serting “(i), or (j)”.

7 (d) FUNDING.—

8 (1) PRESERVING THE DISTRIBUTION OF  
9 GRANTS.—Subsection (s)(2)(B) (as redesignated) of  
10 section 330 of the Public Health Service Act (42  
11 U.S.C. 254b) is amended by striking “the total  
12 amount appropriated to carry out this section for  
13 that fiscal year” and inserting “the total amount ap-  
14 propriated to carry out this section (other than sub-  
15 section (j)) for that fiscal year”.

16 (2) FUNDING REPORT.—Subsection (s)(3)(A)  
17 (as redesignated) of section 330 of the Public  
18 Health Service Act (42 U.S.C. 254b) is amended by  
19 striking “and migratory and seasonal agricultural  
20 workers,” and inserting “migratory and seasonal ag-  
21 ricultural workers, and individuals with a develop-  
22 mental disability,”.

23 (3) AUTHORIZATION OF APPROPRIATIONS.—  
24 Subsection (s) (as redesignated) of section 330 of

1 the Public Health Service Act (42 U.S.C. 254b) is  
2 amended by adding at the end the following:

3 “(7) FUNDING FOR SERVICES FOR INDIVIDUALS  
4 WITH A DEVELOPMENTAL DISABILITY.—To carry  
5 out subsection (j), there is authorized to be appro-  
6 priated \$15,000,000 for each of fiscal years 2026  
7 through 2030.”.

8 (e) INCLUSION FOR PURPOSES OF HEALTH PROFES-  
9 SIONAL SHORTAGE AREAS.—Section 332(a)(3) of the  
10 Public Health Service Act is amended by striking “and  
11 residents of public housing (as defined in section 3(b)(1)  
12 of the United States Housing Act of 1937 (42 U.S.C.  
13 1437a(b)(1)))” and inserting “residents of public housing  
14 (as defined in section 3(b)(1) of the United States Hous-  
15 ing Act of 1937 (42 U.S.C. 1437a(b)(1))), and individuals  
16 with a developmental disability (as defined in section  
17 330(b))”.
