A BILL

To amend the Revised Statutes to remove the defense of qualified immunity in the case of any action under section 1979, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Ending Qualified Im-
5 munity Act”.

6 **SEC. 2. FINDINGS.**

7 Congress finds the following:

1 (1) Congress passed the Act of April 20, 1871
2 (commonly known as the “Ku Klux Klan Act”; 17
3 Stat. 13, chapter 22) to enforce the 14th Amend-
4 ment to the Constitution of the United States and
5 combat rampant violations of civil and constitu-
6 tionally secured rights across the United States, par-
7 ticularly those of newly freed slaves and other Black
8 people in the post-Civil War South.

9 (2) Included in that Act was a provision, now
10 codified at section 1979 of the Revised Statutes (in
11 this section referred to as “section 1983”), which
12 provides a cause of action for individuals to file law-
13 suits against persons acting under color of law, in-
14 cluding State and local officials, who violate their
15 Federal legal and constitutionally secured rights.

16 (3) Under section 1983 a person may be held
17 liable for acting under color of State law, even if
18 they are not acting in accordance with State law.

19 (4) Section 1983 has never included a defense
20 or immunity for government officials who act in
21 good faith when violating rights, nor has it ever had
22 a defense or immunity based on whether the right
23 was “clearly established” at the time of the viola-
24 tion.

1 (5) From 1871 through the 1960s, government
2 actors were not afforded qualified immunity for vio-
3 lating rights.

4 (6) The Supreme Court of the United States in
5 Pierson v. Ray, 386 U.S. 547 (1967), found that
6 government actors had a good-faith defense for mak-
7 ing arrests under unconstitutional statutes based on
8 a common-law defense for the tort of false arrest.

9 (7) The Supreme Court of the United States
10 later extended the good-faith defense beyond false
11 arrests, turning it into a general good-faith defense
12 for government officials.

13 (8) Finally, in Harlow v. Fitzgerald, 457 U.S.
14 800 (1982), the Supreme Court of the United States
15 found the subjective search for good faith in the gov-
16 ernment actor unnecessary, and replaced it with an
17 “objective reasonableness” standard that requires
18 that the right be “clearly established” at the time of
19 the violation for the defendant to be liable.

20 (9) The doctrine of qualified immunity has se-
21 verely limited the ability of many plaintiffs to re-
22 cover damages under section 1983 when their rights
23 have been violated by State and local officials.

24 (10) As a result, the intent of Congress in pass-
25 ing section 1983 has been frustrated, and the rights

1 secured by the Constitution of the United States
2 have not been appropriately protected.

3 **SEC. 3. SENSE OF CONGRESS.**

4 It is the sense of Congress that Congress must cor-
5 rect the erroneous interpretation of section 1979 of the
6 Revised Statutes that provides for qualified immunity and
7 reiterate the standard found on the face of the statute,
8 which does not limit liability on the basis of the good-faith
9 belief of the defendant or on the basis that the right was
10 not “clearly established” at the time of the violation.

11 **SEC. 4. REMOVAL OF QUALIFIED IMMUNITY.**

12 Section 1979 of the Revised Statutes (42 U.S.C.
13 1983) is amended—

14 (1) by inserting “(a)” before “Every person”;
15 and

16 (2) by adding at the end the following:

17 “(b) It shall not be a defense to any action pending
18 on, or filed after, the date of enactment of this subsection
19 that, at the time of the deprivation—

20 “(1) the defendant was acting in good faith;

21 “(2) the defendant believed, reasonably or oth-
22 erwise, that his or her conduct was lawful;

23 “(3) the rights, privileges, or immunities se-
24 cured by the Constitution and laws were not clearly
25 established; or

1 “(4) the state of the law was such that the de-
2 fendant could not reasonably have been expected to
3 know whether his or her conduct was lawful.”.
