## A BILL

To require the Secretary of State to submit to Congress a report on the promotion of certain policies regarding the effects of sea level rise on the statehood and maritime zones of countries, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Maintaining Area  
5       Rights and Integrity Through International Maritime En-  
6       forcement Act” or the “MARITIME Act”.

7       **SEC. 2. FINDINGS.**

8       Congress finds the following:

1           (1) Increasing sea levels pose an existential  
2       threat to low-lying island States in the Pacific  
3       Ocean.

4           (2) Maritime zones are critical for the econo-  
5       mies of the Pacific Islands, which depend on exclu-  
6       sive rights to resources.

7           (3) New trends are developing in the practices  
8       and views of States on the need for stable maritime  
9       zones in the face of sea level rise, as reflected in the  
10      approach taken by the members of the Pacific Is-  
11      lands Forum and the Alliance of Small Island  
12      States.

13 **SEC. 3. STATEMENT OF POLICY.**

14       It is the policy of the United States that—

15           (1) sea level rise driven by climate change  
16      should not cause any country to lose its statehood or  
17      its membership in the United Nations, its specialized  
18      agencies, or other international organizations;

19           (2) the United States is committed to working  
20      with other countries on issues relating to sea level  
21      rise and statehood to advance these objectives;

22           (3) sea level rise driven by climate change  
23      should not diminish the maritime zones on which is-  
24      land States and other coastal States rely, including  
25      for food and livelihoods;

1           (4) the United States is committed to pre-  
2       serving the legitimacy of maritime zones, and associ-  
3       ated rights and entitlements, that have been estab-  
4       lished consistent with international law as reflected  
5       in the United Nations Convention on the Law of the  
6       Sea and that are not subsequently updated despite  
7       sea level rise caused by climate change;

8           (5) countries should support the initiative of the  
9       Pacific Islands Forum and the Alliance of Small Is-  
10      land States to take steps now to determine, memori-  
11      alize, and publish their coastal baselines in accord-  
12      ance with the international law of the sea as set out  
13      in the United Nations Convention on the Law of the  
14      Sea; and

15          (6) the United States will encourage countries  
16      to adopt similar policies on the issue of statehood  
17      and the preservation of maritime zones.

18 **SEC. 4. REPORT.**

19          (a) IN GENERAL.—Not later than 120 days after the  
20      date of the enactment of this Act, the Secretary of State,  
21      in consultation with the heads of other relevant Federal  
22      agencies, shall submit to the appropriate congressional  
23      committees a report on the efforts of the United States  
24      to promote the adoption, by foreign countries and inter-  
25      national organizations, of policies that are complementary

1 to United States policies regarding the effects of sea level  
2 rise on the statehood and maritime zones of countries.

3 (b) REPORT CONTENTS.—The report required by  
4 subsection (a) shall include the following:

5 (1) A comprehensive review of the initiatives of  
6 the Department of State and other relevant depart-  
7 ments and agencies to promote the adoption of poli-  
8 cies described in subsection (a) by foreign countries  
9 and international organizations.

10 (2) An assessment of how the Department of  
11 State and other relevant departments and agencies  
12 are establishing or expanding bilateral and multilat-  
13 eral efforts to encourage the adoption of policies de-  
14 scribed in subsection (a) in international fora.

15 (3) An assessment of any legal, policy,  
16 logistical, financial, or administrative barrier to pro-  
17 moting the adoption of policies described in sub-  
18 section (a).

19 (4) A list of countries and international organi-  
20 zations that have adopted policies described in sub-  
21 section (a).

22 (c) FORM OF REPORT.—The report required under  
23 subsection (a) shall be submitted in unclassified form, but  
24 may include a classified annex.

1       (d) APPROPRIATE CONGRESSIONAL COMMITTEES.—

2   In this section, the term “appropriate congressional com-  
3   mittees” means—

4           (1) the Committee on Foreign Affairs of the  
5       House of Representatives; and

6           (2) the Committee on Foreign Relations of the  
7       Senate.
