# H. R. 3903

## AN ACT

To exchange non-Federal land held by the Chugach Alaska Corporation for certain Federal Land in the Chugach Region, and for other purposes.

1        *Be it enacted by the Senate and House of Representa-*  
2        *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Chugach Alaska Land  
3 Exchange Oil Spill Recovery Act of 2025”.

4 **SEC. 2. PURPOSES.**

5 The purposes of this Act are—

6 (1) to authorize, direct, and expedite the ex-  
7 change of land and interests in land between Chu-  
8 gach Alaska and the United States; and

9 (2) to consolidate Federal ownership of the sur-  
10 face and subsurface estate of Federal land and in-  
11 terests acquired under the Program.

12 **SEC. 3. DEFINITIONS.**

13 In this Act:

14 (1) ANSCA TERMS.—The terms “Native Cor-  
15 poration”, “Regional Corporation”, and “Village  
16 Corporation” have the meanings given those terms  
17 in section 3 of the Alaska Native Claims Settlement  
18 Act (43 U.S.C. 1602).

19 (2) CHUGACH ALASKA.—The term “Chugach  
20 Alaska” means the Chugach Alaska Corporation, a  
21 Regional Corporation.

22 (3) CHUGACH REGION LAND STUDY REPORT.—  
23 The term “Chugach Region Land Study Report”  
24 means the report and recommendations submitted to  
25 Congress by the Secretary pursuant to section 1113  
26 of the John D. Dingell, Jr. Conservation, Manage-

1 ment, and Recreation Act (Public Law 116–9; 133  
2 Stat. 614).

3 (4) FEDERAL EXCHANGE LAND.—The term  
4 “Federal exchange land” means the approximately  
5 65,374 acres of fee simple land located in the Chu-  
6 gach Region as described in section 4(e).

7 (5) NON-FEDERAL LAND.—The term “non-Fed-  
8 eral land” means the parcels of subsurface land  
9 comprising approximately 231,000 acres—

10 (A) owned by Chugach Alaska and con-  
11 veyed to Chugach Alaska pursuant to the Alas-  
12 ka Native Claims Settlement Act (43 U.S.C.  
13 1601 et seq.);

14 (B) described in section 4(f); and

15 (C) for which—

16 (i) the United States has acquired fee  
17 title to the surface estate or a conservation  
18 easement on the surface estate pursuant to  
19 the Program; or

20 (ii) the State has acquired fee title to,  
21 and the United States has acquired a con-  
22 servation easement in, the surface estate  
23 pursuant to the Program.

24 (6) PROGRAM.—The term “Program” means  
25 the Exxon Valdez Oil Spill Habitat Protection and

1 Acquisition Program of the Exxon Valdez Oil Spill  
2 Trustee Council.

3 (7) SECRETARY.—The term “Secretary” means  
4 the Secretary of the Interior.

5 (8) STATE.—The term “State” means the State  
6 of Alaska.

7 **SEC. 4. LAND EXCHANGE.**

8 (a) IN GENERAL.—Not later than 1 year after the  
9 date of enactment of this Act, if Chugach Alaska offers  
10 to convey to the Secretary all right, title, and interest in  
11 and to the non-Federal land, the Secretary shall accept  
12 the offer and convey, pursuant to section 22(j)(1) of the  
13 Alaska Native Claims Settlement Act (43 U.S.C.  
14 1621(j)(1)), all right, title, and interest of the Federal  
15 Government in and to the Federal exchange land subject  
16 to the reservation of public easements required under sec-  
17 tion 17(b) of the Alaska Native Claims Settlement Act (43  
18 U.S.C. 1616(b)).

19 (b) CONDITION ON ACCEPTANCE.—Title to the non-  
20 Federal land exchanged in subsection (a) shall be in a  
21 form that is acceptable to the Secretary.

22 (c) TREATMENT OF LAND CONVEYED.—Except as  
23 otherwise provided, any land conveyed to Chugach Alaska  
24 under subsection (a) shall be considered to be land con-

1 veyed by the Secretary under the Alaska Native Claims  
2 Settlement Act (43 U.S.C. 1601 et seq.).

3 (d) VALID EXISTING RIGHTS.—The conveyances  
4 under subsection (a) shall be subject to any valid existing  
5 rights, reservations, rights-of-way, or other encumbrances  
6 of third parties in, to, or on the Federal exchange land  
7 or the non-Federal land as of the date of enactment of  
8 this Act.

9 (e) CONVEYANCE OF FEDERAL EXCHANGE LAND.—  
10 The Secretary shall, as soon as practicable after the date  
11 of enactment of this Act, convey to Chugach Alaska—

12 (1) all right, title, and interest in and to the  
13 National Forest System land of the Forest Service  
14 identified in the Chugach Regional Land Study and  
15 Report, comprising approximately 63,414 total  
16 acres, comprising—

17 (A) T. 3 N., R. 10 E., Seward Meridian,  
18 Drier Bay Parcel, comprising approximately  
19 2,996 acres of surface estate;

20 (B) T. 17 and 18 S., R. 7 and 8 E., Cop-

15 which Chugach Alaska may convey to the Secretary  
16 all right, title, and interest, that the Secretary deter-  
17 mines to be applicable, includes—

24 (2) MANAGEMENT.—Land acquired by the Sec-  
25 retary under this subsection shall—

1 (A) become part of the unit of Federal  
2 land in which the land acquired by the Sec-  
3 retary is located; and

4 (B) be administered in accordance with  
5 that unit of Federal land.

6 (3) EXCLUSION OF VILLAGE CORPORATION DE-  
7 VELOPMENT AND SHAREHOLDER SITES.—Notwith-  
8 standing paragraph (1), Chugach Alaska shall ex-  
9 clude from the conveyance of non-Federal land all  
10 right, title, and interest in any land, not to exceed  
11 a total of 209 acres, that—

12 (A) a Village Corporation has retained de-  
13 velopment rights, other than timber develop-  
14 ment rights; or

15 (B) has been designated for a shareholder  
16 homesite program.

17 **SEC. 5. MAPS, ESTIMATES, AND DESCRIPTIONS.**

18 (a) MINOR ERRORS.—The Secretary and Chugach  
19 Alaska may correct, by mutual agreement, any minor er-  
20 rors in any map, acreage estimate, or description of any

22 (b) CONFLICT.—If there is a conflict between a map,  
23 an acreage estimate, or a description of land in this Act,

- 1 the map shall control unless the Secretary and Chugach
