A BILL

To exchange non-Federal land held by the Chugach Alaska Corporation for certain Federal Land in the Chugach Region, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Chugach Alaska Land*
5 *Exchange Oil Spill Recovery Act of 2025”.*

6 **SEC. 2. PURPOSES.**

7 *The purposes of this Act are—*

8 *(1) to authorize, direct, and expedite the ex-*
9 *change of land and interests in land between Chugach*
10 *Alaska and the United States; and*

11 *(2) to consolidate Federal ownership of the sur-*
12 *face and subsurface estate of Federal land and inter-*
13 *ests acquired under the Program.*

14 **SEC. 3. DEFINITIONS.**

15 *In this Act:*

16 *(1) ANSCA TERMS.—The terms “Native Cor-*
17 *poration”, “Regional Corporation”, and “Village Cor-*
18 *poration” have the meanings given those terms in sec-*
19 *tion 3 of the Alaska Native Claims Settlement Act (43*
20 *U.S.C. 1602).*

21 *(2) CHUGACH ALASKA.—The term “Chugach*
22 *Alaska” means the Chugach Alaska Corporation, a*
23 *Regional Corporation.*

24 *(3) CHUGACH REGION LAND STUDY REPORT.—*
25 *The term “Chugach Region Land Study Report”*

1 *means the report and recommendations submitted to*
 2 *Congress by the Secretary pursuant to section 1113 of*
 3 *the John D. Dingell, Jr. Conservation, Management,*
 4 *and Recreation Act (Public Law 116–9; 133 Stat.*
 5 *614).*

6 (4) *FEDERAL EXCHANGE LAND.*—*The term “Fed-*
 7 *eral exchange land” means the approximately 65,374*
 8 *acres of fee simple land located in the Chugach Re-*
 9 *gion as described in section 4(e).*

10 (5) *NON-FEDERAL LAND.*—*The term “non-Fed-*
 11 *eral land” means the parcels of subsurface land com-*
 12 *prising approximately 231,000 acres—*

13 (A) *owned by Chugach Alaska and conveyed*
 14 *to Chugach Alaska pursuant to the Alaska Na-*
 15 *tive Claims Settlement Act (43 U.S.C. 1601 et*
 16 *seq.);*

17 (B) *described in section 4(f); and*

18 (C) *for which—*

19 (i) *the United States has acquired fee*
 20 *title to the surface estate or a conservation*
 21 *easement on the surface estate pursuant to*
 22 *the Program; or*

23 (ii) *the State has acquired fee title to,*
 24 *and the United States has acquired a con-*

1 *reservation easement in, the surface estate*
2 *pursuant to the Program.*

3 (6) *PROGRAM.*—*The term “Program” means the*
4 *Exxon Valdez Oil Spill Habitat Protection and Ac-*
5 *quisition Program of the Exxon Valdez Oil Spill*
6 *Trustee Council.*

7 (7) *SECRETARY.*—*The term “Secretary” means*
8 *the Secretary of the Interior.*

9 (8) *STATE.*—*The term “State” means the State*
10 *of Alaska.*

11 **SEC. 4. LAND EXCHANGE.**

12 (a) *IN GENERAL.*—*Not later than 1 year after the date*
13 *of enactment of this Act, if Chugach Alaska offers to convey*
14 *to the Secretary all right, title, and interest in and to the*
15 *non-Federal land, the Secretary shall accept the offer and*
16 *convey, pursuant to section 22(j)(1) of the Alaska Native*
17 *Claims Settlement Act (43 U.S.C. 1621(j)(1)), all right,*
18 *title, and interest of the Federal Government in and to the*
19 *Federal exchange land subject to the reservation of public*
20 *easements required under section 17(b) of the Alaska Native*
21 *Claims Settlement Act (43 U.S.C. 1616(b)).*

22 (b) *CONDITION ON ACCEPTANCE.*—*Title to the non-*
23 *Federal land exchanged in subsection (a) shall be in a form*
24 *that is acceptable to the Secretary.*

1 (c) *TREATMENT OF LAND CONVEYED.*—*Except as oth-*
2 *erwise provided, any land conveyed to Chugach Alaska*
3 *under subsection (a) shall be considered to be land conveyed*
4 *by the Secretary under the Alaska Native Claims Settlement*
5 *Act (43 U.S.C. 1601 et seq.).*

6 (d) *VALID EXISTING RIGHTS.*—*The conveyances under*
7 *subsection (a) shall be subject to any valid existing rights,*
8 *reservations, rights-of-way, or other encumbrances of third*
9 *parties in, to, or on the Federal exchange land or the non-*
10 *Federal land as of the date of enactment of this Act.*

11 (e) *CONVEYANCE OF FEDERAL EXCHANGE LAND.*—*The*
12 *Secretary shall, as soon as practicable after the date of en-*
13 *actment of this Act, convey to Chugach Alaska—*

14 (1) *all right, title, and interest in and to the Na-*
15 *tional Forest System land of the Forest Service iden-*
16 *tified in the Chugach Regional Land Study and Re-*
17 *port, comprising approximately 63,414 total acres,*
18 *comprising—*
