## A BILL

To amend title XVIII of the Social Security Act to provide coverage and payment under such title for certain treatments for dialysis-related amyloidosis, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Dialysis-Related Amy-  
5       loidosis Treatment Act of 2025”.

1 **SEC. 2. COVERAGE AND PAYMENT FOR TREATMENTS FOR**  
 2 **DIALYSIS-RELATED AMYLOIDOSIS UNDER**  
 3 **THE MEDICARE PROGRAM.**

4 (a) COVERAGE.—Section 1861(s)(2) of the Social Se-  
 5 curity Act (42 U.S.C. 1395x(s)(2)), is amended—

6 (1) in subparagraph (JJ), by inserting “and”  
 7 at the end; and

8 (2) by adding at the end the following new sub-  
 9 paragraph:

10 “(KK) treatments for dialysis-related amyloi-  
 11 dosis (as defined in subsection (nnn));”.

12 (b) TREATMENTS FOR DIALYSIS-RELATED AMYLOI-  
 13 DOSIS DEFINED.—

14 (1) IN GENERAL.—Section 1861 of the Social  
 15 Security Act (42 U.S.C. 1395x), is amended by add-  
 16 ing at the end the following new subsection:

17 “(nnn) TREATMENTS FOR DIALYSIS-RELATED AMY-  
 18 LOIDOSIS.—The term ‘treatments for dialysis-related amy-  
 19 loidosis’ means any item or service that is furnished in  
 20 a dialysis facility (freestanding or hospital-based) that is  
 21 approved by the Food and Drug Administration for the  
 22 treatment of dialysis-related amyloidosis, and any supplies  
 23 or services that are provided adjunct to and are necessary  
 24 for such treatment.”.

25 (2) EXCLUSION FROM RENAL DIALYSIS SERV-  
 26 ICES.—Section 1881(b)(14)(B) of the Social Secu-

1        rity Act (42 U.S.C. 1395rr(b)(14)(B)) is amended  
2        by inserting before the period at the end the fol-  
3        lowing: “or ‘treatments for dialysis-related amyloi-  
4        dosis’ (as defined in section 1861(nnn))”.

5        (c) PAYMENT.—Section 1833(a)(1)(E) of the Social  
6        Security Act (42 U.S.C. 1395l(a)(1)(E)) is amended by  
7        inserting at the end the following: “except for treatments  
8        for dialysis-related amyloidosis, which may not be included  
9        as a renal dialysis service for purposes of payment under  
10       any prospective payment amount or comprehensive fee es-  
11       tablished under section 1881, and for which payment shall  
12       be made separately in the amount of 100 percent of the  
13       reasonable charges for such items and services,”.

14       (d) EFFECTIVE DATE.—The amendments made by  
15       this section shall take effect on the date of the enactment  
16       of this Act.
