Ms. WILLIAMS of Georgia introduced the following bill; which was referred to the Committee on Homeland Security

A BILL

To direct the Under Secretary for Intelligence and Analysis of the Department of Homeland Security to develop and disseminate a threat assessment regarding threats to the United States associated with foreign violent white supremacist extremist organizations, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Countering White Su-
5 premacist Extremism Act”.

1 **SEC. 2. THREAT ASSESSMENT.**

2 (a) IN GENERAL.—The Under Secretary for Intel-
3 ligence and Analysis of the Department of Homeland Se-
4 curity shall, in coordination with appropriate Federal
5 partners, develop a terrorism threat assessment and ref-
6 erence aid regarding threats to the United States associ-
7 ated with foreign violent white supremacist extremist or-
8 ganizations. Consistent with the protection of classified
9 and confidential unclassified information, the Under Sec-
10 retary shall share the threat assessment developed under
11 this section with State, local, and Tribal law enforcement
12 officials, including officials who operate within State, local,
13 and regional fusion centers through the Department of
14 Homeland Security State, Local, and Regional Fusion
15 Center Initiative established in accordance with section
16 210A of the Homeland Security Act of 2002 (6 U.S.C.
17 124h).

18 (b) FOUNDATION, INCORPORATION, AND COORDINA-
19 TION.—The threat assessment and reference aid developed
20 pursuant to subsection (a)—

21 (1) shall be—

22 (A) based on and incorporate appropriate
23 elements of the Department of State Strategy
24 for Countering White Identity Terrorism Glob-
25 ally required under section 1299F of the Wil-
26 liam M. (Mac) Thornberry National Defense

1 Authorization Act for Fiscal Year 2021 (Public
2 Law 116–283; 22 U.S.C. 2656j); and

3 (B) developed in coordination with the Of-
4 fice of Civil Rights and Civil Liberties of the
5 Department of Homeland Security and other
6 appropriate Federal agencies; and

7 (2) may be informed by existing products devel-
8 oped by such Office and agencies, as appropriate.

9 (c) OVERVIEW.—The threat assessment and ref-
10 erence aid shall include an overview of symbols, flags, or
11 other references utilized by adherents of foreign violent
12 white supremacist extremist organizations.

13 (d) DISTRIBUTION.—Consistent with the protection
14 of classified and confidential unclassified information, the
15 Under Secretary for Intelligence and Analysis of the De-
16 partment of Homeland Security shall share the threat as-
17 sessment and reference aid with the following:

18 (1) State, local, and Tribal law enforcement of-
19 ficials, including officials who operate within State,
20 local, and regional fusion centers through the De-
21 partment of Homeland Security State, Local, and
22 Regional Fusion Center Initiative established in ac-
23 cordance with section 210A of the Homeland Secu-
24 rity Act of 2002 (6 U.S.C. 124h).

1 (2) Appropriate owners and operators of online
2 platforms to assist in identifying content that may
3 be associated with a foreign violent white suprema-
4 cist extremist organization that may violate the
5 terms of service of such online platforms, upon re-
6 quest from such online platforms and in consultation
7 with the Office of Civil Rights and Civil Liberties of
8 the Department.

9 (e) DEFINITIONS.—In this section:

10 (1) FOREIGN VIOLENT WHITE SUPREMACIST
11 EXTREMIST ORGANIZATION.—The term “foreign vio-
12 lent white supremacist extremist organization”
13 means an organization based outside the United
14 States that seeks, wholly or in part, through unlaw-
15 ful acts of force or violence, to support a belief in
16 the intellectual and moral superiority of the white
17 race over other races.

18 (2) ONLINE PLATFORM.—The term “online
19 platform” means internet-based information services
20 consisting of the storage and processing of informa-
21 tion by and at the request of a content provider and
22 the dissemination of such content to third parties.

23 (f) LIMITATION.—The Under Secretary for Intel-
24 ligence and Analysis of the Department of Homeland Se-
25 curity shall ensure that the threat assessment and ref-

1 erence aid does not contain the name or other identifiable
2 information of any individual or organization engaged in
3 lawful political or public discourse in the United States
4 protected under the United States Constitution.
