A BILL

2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Whistleblower Protection*
5 *Act of 2025”.*

6 **SEC. 2. WHISTLEBLOWER PROTECTIONS FOR DEPARTMENT**
7 **OF HOUSING AND URBAN DEVELOPMENT**
8 **CONTRACTS.**

9 *Section 4712 of title 41, United States Code, shall*
10 *apply with respect to any contract, subcontract, grant,*
11 *subgrant, or personal services contract funded using*
12 *amounts appropriated to the Secretary of Housing and*
13 *Urban Development, regardless of when the contract, sub-*
14 *contract, grant, subgrant, or personal services contract was*
15 *executed.*
