## A BILL

To amend the Food and Nutrition Act of 2008 to simplify supplemental nutrition assistance program access for elderly and disabled individuals.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

### 3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Increasing Nutrition  
5 Access for Seniors Act of 2025”.

### 6 **SEC. 2. AMENDMENTS.**

7 (a) DEFINITION.—Section 3(f) of the Food and Nu-  
8 trition Act of 2008 (7 U.S.C. 2012(f)) is amended in the

1 second sentence by inserting “, or 36 months if that  
2 household has no earned income” before the period at the  
3 end.

4 (b) EXCESS MEDICAL EXPENSE DEDUCTION.—Sec-  
5 tion 5(e)(5)(A) of the Food and Nutrition Act of 2008  
6 (7 U.S.C. 2014(e)(5)(A)) is amended—

7 (1) by inserting “(i)” before “A”, and

8 (2) by adding at the end the following:

9 “(ii)(I) A State agency may establish a  
10 standard medical deduction option for elderly or  
11 disabled household members who self-attest to  
12 having medical expenses in excess of \$35 a  
13 month (exclusive of special diets).

14 “(II) The standard medical deduction  
15 amount shall be—

16 “(aa) for fiscal year 2026, \$155; and

17 “(bb) for each subsequent fiscal year,  
18 equal to the applicable amount for the im-  
19 mediately preceding fiscal year as adjusted  
20 to reflect changes for the 12-month period  
21 ending the preceding June 30 in the Con-  
22 sumer Price Index for All Urban Con-  
23 sumers: Medical Care published by the Bu-  
24 reau of Labor Statistics of the Department  
25 of Labor.

1                   “(III) For any fiscal year, a State agency  
 2                   may establish a greater standard medical ex-  
 3                   pense deduction than described in subclause  
 4                   (II) if the State provides reasonable evidence  
 5                   for a more accurate assessment of average  
 6                   monthly medical costs in their State.”.

7           (c) ADMINISTRATION.—Section 11(e)(3) of the Food  
 8 and Nutrition Act of 2008 (7 U.S.C. 2020(e)(3)) is  
 9 amended by inserting after “this Act” the second place  
 10 it appears the following:

11           “(except that State agency may use data matches in lieu  
 12 of income verification if the household qualifies for a 36-  
 13 month certification period under section 3(f))”.

14 **SEC. 3. EFFECTIVE DATE; APPLICATION OF AMENDMENTS.**

15           (a) EFFECTIVE DATE.—Except as provided in sub-  
 16 section (b), this Act and the amendments made by this  
 17 Act shall take effect 180 days after the date of the enact-  
 18 ment of this Act.

19           (b) APPLICATION OF AMENDMENTS.—The amend-  
 20 ments made by this Act shall not apply with respect to  
 21 certification periods that begin before the effective date  
 22 of this Act.
