A BILL

To amend section 7014 of the Elementary and Secondary Education Act of 1965 to advance toward full Federal funding for impact aid, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Advancing Toward Im-
5 pact Aid Full Funding Act”.

6 **SEC. 2. AMENDMENT TO ESEA.**

7 Section 7014 of the Elementary and Secondary Edu-
8 cation Act of 1965 (20 U.S.C. 7714) is amended by strik-

1 ing subsections (a) through (d) and inserting the fol-
 2 lowing:

3 “(a) PAYMENTS FOR FEDERAL ACQUISITION OF
 4 REAL PROPERTY.—For the purpose of making payments
 5 under section 7002, there are authorized to be appro-
 6 priated—

7 “(1) \$85,000,000 for fiscal year 2026;

8 “(2) \$118,000,000 for fiscal year 2027;

9 “(3) \$151,000,000 for fiscal year 2028;

10 “(4) \$184,000,000 for fiscal year 2029;

11 “(5) \$217,000,000 for fiscal year 2030; and

12 “(6) \$250,000,000 for fiscal year 2031.

13 “(b) BASIC PAYMENTS; PAYMENTS FOR HEAVILY IM-
 14 PACTED LOCAL EDUCATIONAL AGENCIES.—For the pur-
 15 pose of making payments under section 7003(b), there are
 16 authorized to be appropriated—

17 “(1) \$1,487,058,000 for fiscal year 2026;

18 “(2) \$1,659,178,000 for fiscal year 2027;

19 “(3) \$1,831,298,000 for fiscal year 2028;

20 “(4) \$2,003,418,000 for fiscal year 2029;

21 “(5) \$2,175,538,000 for fiscal year 2030; and

22 “(6) \$2,347,658,000 for fiscal year 2031.

23 “(c) PAYMENTS FOR CHILDREN WITH DISABIL-
 24 ITIES.—For the purpose of making payments under sec-
 25 tion 7003(d), there are authorized to be appropriated—

- 1 “(1) \$50,000,000 for fiscal year 2026;
2 “(2) \$64,000,000 for fiscal year 2027;
3 “(3) \$78,000,000 for fiscal year 2028;
4 “(4) \$92,000,000 for fiscal year 2029;
5 “(5) \$106,000,000 for fiscal year 2030; and
6 “(6) \$120,000,000 for fiscal year 2031.

7 “(d) CONSTRUCTION.—For the purpose of carrying
8 out section 7007, there are authorized to be appro-
9 priated—

- 10 “(1) \$20,000,000 for fiscal year 2026;
11 “(2) \$25,000,000 for fiscal year 2027;
12 “(3) \$30,000,000 for fiscal year 2028;
13 “(4) \$35,000,000 for fiscal year 2029;
14 “(5) \$40,000,000 for fiscal year 2030; and
15 “(6) \$45,000,000 for fiscal year 2031.”.
