Mr. BISHOP (for himself and Mrs. KIGGANS of Virginia) introduced the following bill; which was referred to the Committee on Armed Services

A BILL

To amend title 10, United States Code, to modify the semi-annual report on privatized military housing, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Military Housing Per-
5 formance Insight Act”.

6 **SEC. 2. MODIFICATION OF SEMI-ANNUAL REPORT ON**
7 **PRIVATIZED MILITARY HOUSING.**

8 (a) IN GENERAL.—Subsection (c) of section 2884 of
9 title 10, United States Code, is amended by adding at the
10 end the following new paragraphs:

1 “(15) An overview of the housing data being
2 used by the Department and the housing data being
3 sought from management companies.

4 “(16) An assessment of how the Secretary of
5 each military department is using such housing data
6 to inform the on-base housing decisions for such
7 military department.

8 “(17) An explanation of the limitations of any
9 customer satisfaction data collected (including with
10 respect to the availability of survey data), the proc-
11 ess for determining resident satisfaction, and rea-
12 sons for missing data.

13 “(18) To the maximum extent practicable, a
14 breakdown of the information under this paragraph
15 by installation and military housing project.”.

16 (b) PUBLIC REPORTING.—Such subsection is further
17 amended—

18 (1) in paragraph (14), by redesignating sub-
19 paragraphs (A) through (D) as clauses (i) through
20 (iv), respectively;

21 (2) by redesignating paragraphs (1) through
22 (18) as subparagraphs (A) through (R), respectively;

23 (3) in subparagraph (E), as redesignated by
24 paragraph (2), by striking “paragraphs (1) through

1 (4)” and inserting “subparagraphs (A) through
2 (D)”;

3 (4) in the matter preceding subparagraph (A),
4 as so redesignated, by striking “The Secretary” and
5 inserting “(1) The Secretary”; and

6 (5) by adding at the end the following new
7 paragraph:

8 “(2) Not later than 30 days after submitting a report
9 under paragraph (1), the Secretary of Defense shall pub-
10 lish the report on a publicly available website of the De-
11 partment of Defense.”.

12 (c) TECHNICAL AMENDMENT.—The heading for such
13 subsection is amended by striking “ANNUAL” and insert-
14 ing “SEMI-ANNUAL”.

15 (d) CONFORMING AMENDMENT.—Subsection (d)(1)
16 of such section is amended by striking “paragraphs (1)
17 through (14) of subsection (c)” and inserting “subpara-
18 graphs (A) through (R) of subsection (c)(1)”.
