A BILL

To require the immediate release of funds appropriated for the supplemental nutrition assistance program (SNAP) and the special supplemental nutrition program for women, infants, and children (WIC), and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “SNAP BACK Act.”

1 **SEC. 2. APPROPRIATION.**

2 (a) IN GENERAL.—In fiscal year 2026 and each fiscal
3 year thereafter, for any period during which interim con-
4 tinuing appropriations or full-year appropriations for that
5 fiscal year have not been enacted for the Department of
6 Agriculture, there are appropriated to the Secretary of Ag-
7 riculture, such sums as are necessary to provide uninter-
8 rupted benefits under—

9 (1) the supplemental nutrition assistance pro-
10 gram established under the Food and Nutrition Act
11 of 2008 (7 U.S.C 2011 et seq.); and

12 (2) the special supplemental nutrition program
13 for women, infants, and children established by sec-
14 tion 17 of the Child Nutrition Act of 1966 (42
15 U.S.C. 1786).

16 **SEC. 3. REQUIREMENT TO RELEASE FUNDS.**

17 (a) IMMEDIATE OBLIGATION OF FUNDS.—Notwith-
18 standing any other provision of law, the Secretary of Agri-
19 culture shall, immediately upon enactment of this Act, ob-
20 ligate and make available all funds appropriated by Con-
21 gress for—

22 (1) the supplemental nutrition assistance pro-
23 gram; and

24 (2) the special supplemental nutrition program
25 for women, infants, and children.

1 (b) PROHIBITION ON WITHHOLDING.—No officer or
2 employee of the executive branch, including the Office of
3 Management and Budget, or U.S. Department of Agri-
4 culture may withhold, delay, or otherwise impede the re-
5 lease or obligation of such funds for any reason not explic-
6 itly authorized by statute.

7 (c) REQUIREMENT TO ENROLL.—

8 (1) CONTINUED ENROLLMENT.—The Secretary
9 of Agriculture shall ensure that, all State agencies
10 administering SNAP or WIC continue to accept,
11 process, and approve applications for individuals and
12 households that meet the statutory eligibility re-
13 quirements for such programs.

14 (2) ACCESS TO BENEFITS.—Individuals deter-
15 mined eligible under paragraph (1) shall receive ben-
16 efits as soon as funds are available, and no later
17 than five days after the Secretary obligates the
18 funds made available under subsection (a).

19 (3) PROHIBITION ON ENROLLMENT FREEZE.—
20 No Federal or State official may institute an enroll-
21 ment freeze, waiting list, or other restriction on par-
22 ticipation in SNAP or WIC due to any delay or
23 withholding of funds.

1 **SEC. 4. CONTINUITY OF EBT CARD ACCESS AND PROC-**
2 **ESSING.**

3 (a) UNINTERRUPTED OPERATION.—The Secretary of
4 Agriculture shall ensure the uninterrupted operation and
5 functionality of all Electronic Benefit Transfer (EBT) sys-
6 tems used to distribute SNAP and WIC benefits, including
7 during any lapse in appropriations or due to an adminis-
8 trative delay.

9 (b) TIMELY DISBURSEMENT.—State agencies admin-
10 istering SNAP or WIC shall, upon receipt of Federal
11 funds, immediately load benefits onto EBT cards for eligi-
12 ble households without additional delay.

13 (c) PROHIBITION ON SUSPENSION OF BENEFITS.—
14 No Federal or State agency may suspend, deactivate, or
15 otherwise restrict the use of EBT cards due to any tem-
16 porary funding delay.

17 **SEC. 5. REIMBURSEMENT OF STATES OR TRIBES.**

18 (a) REIMBURSEMENT OF STATE OR TRIBE.—The
19 Secretary of Agriculture shall reimburse any State of fed-
20 erally recognized American Indian Tribe that makes an
21 emergency appropriation of State or tribal funds to cover
22 a lapse in Federal funding for these programs up to the
23 amount expended by the State or tribe.
