A BILL

To amend the Migratory Bird Treaty Act to clarify the treatment of authentic Alaska Native articles of handicraft containing nonedible migratory bird parts, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Archie Cavanaugh Mi-*
 5 *gratory Bird Treaty Clarification Act”.*

6 **SEC. 2. PURPOSE.**

7 *The purpose of this Act is to clarify the treatment of*
 8 *authentic Alaska Native articles of handicraft offered for*
 9 *sale under the Convention between the United States and*
 10 *Japan for the Protection of Migratory Birds and Birds in*
 11 *Danger of Extinction and Their Environment, signed at*
 12 *Tokyo March 4, 1974 (TIAS 7990).*

13 **SEC. 3. CLARIFICATION FOR AUTHENTIC ALASKA NATIVE**
 14 **ARTICLES OF HANDICRAFT CONTAINING MI-**
 15 **GRATORY BIRD PARTS.**

16 *(a) IN GENERAL.—Not later than 180 days after the*
 17 *date of the enactment of this Act—*

18 *(1) the Secretary of State shall work with the*
 19 *Secretary of the Interior to enter into appropriate bi-*
 20 *lateral procedures, as necessary, with the foreign*
 21 *country that is party to the treaty described in sec-*
 22 *tion 2 to clarify the treatment of authentic Alaska*
 23 *Native articles of handicraft to be offered for sale con-*
 24 *taining nonedible migratory bird parts from the spe-*
 25 *cies of migratory birds listed in the treaty; and*

1 (2) *the Secretary of the Interior may modify any*
2 *regulations implementing the Migratory Bird Treaty*
3 *Act (16 U.S.C. 703 et seq.), as appropriate, consistent*
4 *with the treaty described in section 2, in consultation*
5 *with the foreign country that is party to the treaty,*
6 *the Alaska Migratory Bird Co-Management Council,*
7 *and the Pacific Flyway Council, and in coordination*
8 *with the Law Enforcement Office of the United States*
9 *Fish and Wildlife Service, to implement any nec-*
10 *essary clarifications resulting from the procedures de-*
11 *scribed in paragraph (1), including conditions for*
12 *consignment and re-sale, certification of authenticity,*
13 *and provisions pertaining to species of conservation*
14 *concern.*

15 (b) *MODIFICATION OF REGULATIONS.—If the Sec-*
16 *retary of the Interior determines that any of the species used*
17 *under this section show significant population declines or*
18 *is determined to be a Bird of Conservation Concern pursu-*
19 *ant to section 13 of the Fish and Wildlife Conservation Act*
20 *of 1980 (16 U.S.C. 2912), the Secretary may modify regula-*
21 *tions to remove the species from application under this sec-*
22 *tion.*

23 (c) *OUTREACH.—The Secretary of the Interior shall*
24 *work in collaboration with the Alaska Migratory Bird Co-*
25 *Management Council and other appropriate stakeholders to*

1 *develop outreach and communication resources and means*
 2 *to communicate rules pertaining to the sale of authentic*
 3 *Alaska Native articles of handicraft including parts of mi-*
 4 *gratory birds.*

5 (d) *TECHNICAL AMENDMENT.—Section 2(a) of the Mi-*
 6 *gratory Bird Treaty Act (16 U.S.C. 703) is amended by*
 7 *inserting a comma after “March 4, 1972”.*

8 (e) *DEFINITIONS.—In this Act:*

9 (1) *ALASKA NATIVE.—The term “Alaska Native”*
 10 *means a member of any Indian Tribe that is based*
 11 *in the State of Alaska, as verified through issuance*
 12 *of—*

13 (A) *a Tribal enrollment card;*

14 (B) *a Certificate of Degree of Indian Blood*
 15 *(commonly known as a “CDIB”) by the Bureau*
 16 *of Indian Affairs; or*

17 (C) *a permit under the Silver Hand pro-*
 18 *gram of the Alaska State Council on the Arts.*

19 (2) *AUTHENTIC ALASKA NATIVE ARTICLE OF*
 20 *HANDICRAFT.—The term “authentic Alaska Native*
 21 *article of handicraft”—*

22 (A) *means any item that is—*

23 (i) *composed, wholly or in a signifi-*
 24 *cant respect, of natural materials that were*
 25 *found, foraged, or gifted; and*

1 (ii) produced, decorated, or fashioned
2 in significant part—

3 (I) by an Alaska Native;

4 (II) in the exercise of traditional
5 Alaska Native handicrafts; and

6 (III) without the use of any mass
7 copying device;

8 (B) includes—

9 (i) any weaving, carving, stitching,
10 sewing, lacing, beading, drawing, or paint-
11 ing that meets the criteria described in
12 clause (i); and

13 (ii) any item, including clothing, de-
14 scribed in subclause (I) that combines the
15 techniques described in that subclause; and

16 (C) does not include any item that contains
17 a part of a migratory bird that was taken in a
18 wasteful or illegal manner.

19 (3) *INDIAN TRIBE*.—The term “Indian Tribe”
20 has the meaning given the term in section 4 of the In-
21 dian Self-Determination and Education Assistance
22 Act (25 U.S.C. 5304).

Amend the title so as to read: “A bill to clarify the treatment of authentic Alaska Native articles of handicraft containing nonedible migratory bird parts under the Migratory Bird Treaty Act, and for other purposes.”.
