A BILL

To require institutions of higher education to disseminate information on the rights of, and accommodations and resources for, pregnant students, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Pregnant Students’*
5 *Rights Act”.*

6 **SEC. 2. NOTICE OF PREGNANT STUDENT RIGHTS, ACCOM-**
7 **MODATIONS, AND RESOURCES.**

8 *Section 485 of the Higher Education Act of 1965 (20*
9 *U.S.C. 1092) is amended by adding at the end the following:*

10 “(n) *PREGNANT STUDENTS’ RIGHTS, ACCOMMODA-*
11 *TIONS, AND RESOURCES.—*

12 “(1) *IN GENERAL.—Each institution of higher*
13 *education participating in any program under this*
14 *title shall carry out the information dissemination*
15 *activities described in paragraph (3) for prospective*
16 *and enrolled students (including those attending or*
17 *planning to attend less than full time) regarding the*
18 *information described in paragraph (2) on the rights*
19 *of, and resources (including protections and accom-*
20 *modations) for, pregnant students to carry a baby to*
21 *term and students who may become pregnant while*
22 *enrolled at such institution of higher education to*
23 *carry a baby to term.*

24 “(2) *INFORMATION CONTENT.—The information*
25 *described in this paragraph is the following:*

1 “(A) *A list of resources on campus and in*
 2 *the community that exist to help a pregnant stu-*
 3 *dent in carrying the baby to term and caring for*
 4 *the baby after birth.*

5 “(B) *Information about the accommoda-*
 6 *tions available to help a pregnant student carry*
 7 *the baby to term and parent the baby after birth.*

8 “(C) *Information on how to file a com-*
 9 *plaint with—*

10 “(i) *the Department of Education, if a*
 11 *student believes there was a violation by the*
 12 *institution of title IX of the Education*
 13 *Amendments of 1972 (20 U.S.C. 1681 et*
 14 *seq.) on account of such student’s deter-*
 15 *mination to carry a baby to term; and*

16 “(ii) *the institution, if a student be-*
 17 *lieves the student has been discriminated*
 18 *against in violation of such title IX on ac-*
 19 *count of the student’s determination to*
 20 *carry a baby to term.*

21 “(3) *INFORMATION DISSEMINATION ACTIVI-*
 22 *TIES.—The information dissemination activities de-*
 23 *scribed in this paragraph shall include—*

24 “(A) *an email to each enrolled student at*
 25 *least once each academic year; and*

1 “(B) the provision of information—
2 “(i) in student handbooks, if any;
3 “(ii) at each orientation for enrolled
4 students;
5 “(iii) at student health or counseling
6 centers, if any; and
7 “(iv) on the publicly available website
8 of the institution of higher education.
9 “(4) *RULE OF CONSTRUCTION.*—Nothing in this
10 subsection shall be construed to authorize the Sec-
11 retary to require the dissemination of additional in-
12 formation, or establish additional rights, beyond the
13 information and rights included in this subsection.”.
