# **A BILL**

To establish the Chiricahua National Park in the State of Arizona as a unit of the National Park System, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Chiricahua National*  
 5 *Park Act”.*

6 **SEC. 2. DESIGNATION OF CHIRICAHUA NATIONAL PARK, AR-**  
 7 **IZONA.**

8 *(a) DESIGNATION.—*

9 *(1) IN GENERAL.—The Chiricahua National*  
 10 *Monument in the State of Arizona established by*  
 11 *Presidential Proclamation 1692 (54 U.S.C. 320301*  
 12 *note; 43 Stat. 1946) shall be known and designated*  
 13 *as “Chiricahua National Park” (referred to in this*  
 14 *Act as the “National Park”).*

15 *(2) BOUNDARIES.—The boundaries of the Na-*  
 16 *tional Park shall be the boundaries of the Chiricahua*  
 17 *National Monument as of the date of enactment of*  
 18 *this Act, as generally depicted on the map entitled*  
 19 *“Chiricahua National Park Proposed Boundary”,*  
 20 *numbered 145/156,356, and dated March 2021.*

21 *(3) REFERENCES.—Any reference in a law, map,*  
 22 *regulation, document, or other record of the United*  
 23 *States to the Chiricahua National Monument shall be*  
 24 *considered to be a reference to the “Chiricahua Na-*  
 25 *tional Park”.*

1           (4) *AVAILABILITY OF FUNDS.*—*Any funds avail-*  
 2           *able for the Chiricahua National Monument shall be*  
 3           *available for the National Park.*

4           (b) *ADMINISTRATION.*—*The Secretary of the Interior*  
 5           *shall administer the National Park in accordance with—*

6                 (1) *Presidential Proclamation 1692 (54 U.S.C.*  
 7                 *320301 note; 43 Stat. 1946);*

8                 (2) *Presidential Proclamation 2288 (54 U.S.C.*  
 9                 *320301 note; 52 Stat. 1551); and*

10                (3) *the laws generally applicable to units of the*  
 11                *National Park System, including—*

12                         (A) *section 100101(a), chapter 1003, and*  
 13                         *sections 100751(a), 100752, 100753, and 102101*  
 14                         *of title 54, United States Code; and*

15                         (B) *chapter 3201 of title 54, United States*  
 16                         *Code.*

17 **SEC. 3. TRADITIONAL CULTURAL AND RELIGIOUS SITES.**

18           (a) *PROTECTION OF SITES.*—

19                 (1) *IN GENERAL.*—*The Secretary shall ensure the*  
 20                 *protection of traditional cultural and religious sites*  
 21                 *in the National Park in accordance with the laws (in-*  
 22                 *cluding regulations) applicable to the Secretary.*

23                 (2) *CONSULTATION.*—*In carrying out paragraph*  
 24                 (1), *the Secretary shall consult with Indian Tribes in*

1       *accordance with laws applicable to the protection of*  
2       *cultural and religious sites.*

3       **(b) ACCESS.**—

4               **(1) IN GENERAL.**—*The Secretary, in accordance*  
5       *with Public Law 95–341 (42 U.S.C. 1996 et seq.)—*

6               **(A)** *shall provide access to the sites de-*  
7       *scribed in subsection (a)(1) by members of In-*  
8       *Indian Tribes for traditional cultural and cus-*  
9       *tomary uses; and*

10              **(B)** *may, on request of an Indian Tribe,*  
11       *temporarily close to general public use one or*  
12       *more specific areas of the National Park to pro-*  
13       *tect traditional cultural and customary uses in*  
14       *the area by members of the Indian Tribe.*

15              **(2) LIMITATION.**—*In closing a portion of a des-*  
16       *ignated area under paragraph (1)(B), the Secretary*  
17       *shall limit the closure to the smallest practicable area*  
18       *for the minimum period necessary for the traditional*  
19       *cultural and religious activities.*

20       **(c) DEFINITIONS.**—*In this section:*

21              **(1) INDIAN TRIBE.**—*The term “Indian Tribe”*  
22       *has the meaning given such term in section 4 of the*  
23       *Indian Self-Determination and Education Assistance*  
24       *Act (25 U.S.C. 5304).*

- 1           (2) *SECRETARY*.—*The term “Secretary” means*  
2           *the Secretary of the Interior.*

Amend the title so as to read: “A bill to redesignate the Chiricahua National Monument in the State of Arizona as Chiricahua National Park, and for other purposes.”.
