A BILL

To direct the Secretary of Agriculture to convey certain
Federal land to the City of The Dalles, Oregon.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Dalles Watershed Devel-*
 5 *opment Act”.*

6 **SEC. 2. DEFINITIONS.**

7 *In this Act:*

8 (1) *CITY.*—*The term “City” means the City of*
 9 *The Dalles, Oregon.*

10 (2) *SECRETARY.*—*The term “Secretary” means*
 11 *the Secretary of the Agriculture, acting through the*
 12 *Chief of the Forest Service.*

13 **SEC. 3. THE DALLES CONVEYANCE.**

14 (a) *IN GENERAL.*—*If, not later than 1 year after the*
 15 *date of the enactment of this Act, the City submits a written*
 16 *request to the Secretary for conveyance of the land described*
 17 *in subsection (b)(1), the Secretary shall, as soon as prac-*
 18 *ticable thereafter, convey to the City, all right, title, and*
 19 *interest of the United States in and to such land.*

20 (b) *DESCRIPTION OF LAND.*—

21 (1) *IN GENERAL.*—*The land described in this*
 22 *paragraph is the parcel of real property generally de-*
 23 *scribed as “parcel A” on the map, consisting of ap-*
 24 *proximately 150 acres of National Forest System land*

1 *located in the Mount Hood National Forest in Or-*
 2 *egon.*

3 (2) *MAP.*—

4 (A) *DEFINITION.*—*In this section, the term*
 5 *“map” means the map entitled “The Dalles Con-*
 6 *veyance Parcel A” and dated November 4, 2024.*

7 (B) *MINOR ERRORS.*—*The Secretary may*
 8 *correct minor errors in the map.*

9 (C) *AVAILABILITY OF MAP.*—*A copy of the*
 10 *map shall be on file and available for public in-*
 11 *spection in the appropriate offices of Forest*
 12 *Service.*

13 (3) *SURVEY.*—*The exact acreage and legal de-*
 14 *scription of the National Forest System land to be*
 15 *conveyed under subsection (a) shall be determined by*
 16 *a survey satisfactory to the Secretary.*

17 (c) *TERMS AND CONDITIONS.*—*The conveyance under*
 18 *subsection (a) shall be—*

19 (1) *subject to valid existing rights;*

20 (2) *made without consideration;*

21 (3) *made by quitclaim deed; and*

22 (4) *subject to such additional terms and condi-*
 23 *tions as the Secretary determines to be appropriate to*
 24 *protect the interests of the United States.*

1 (d) *ADMINISTRATIVE COSTS.*—As a condition of the
2 conveyance under subsection (a), the City shall pay all costs
3 associated with the conveyance, including the cost of a sur-
4 vey under subsection (b)(3).

5 (e) *USE OF CONVEYED LAND.*—

6 (1) *IN GENERAL.*—The land conveyed to the City
7 under subsection (a) shall be used by the City for pub-
8 lic purposes, including for municipal water supply
9 and use and related infrastructure needs or expan-
10 sions.

11 (2) *REVERSION.*—If the land conveyed under
12 subsection (a) is used in a manner that is incon-
13 sistent with the requirement of paragraph (1), all
14 right, title, and interest in and to the land shall re-
15 vert to the United States.
