A BILL

To designate the area of 16th Street Northwest between H Street Northwest and K Street Northwest in the District of Columbia as the “Charlie Kirk Freedom of Speech Plaza”, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Charlie Kirk Freedom
5 of Speech Plaza Act”.

6 **SEC. 2. DESIGNATION OF CHARLIE KIRK FREEDOM OF**
7 **SPEECH PLAZA.**

8 (a) DESIGNATION OF PLAZA.—

1 (1) IN GENERAL.—The area of 16th Street
2 Northwest between H Street Northwest and K
3 Street Northwest in the District of Columbia (for-
4 merly symbolically designated as “Black Lives Mat-
5 ter Plaza” under the Black Lives Matter Plaza Des-
6 ignation Act of 2020 (sec. 9–204.01 note, DC Offi-
7 cial Code)), shall be known and designated as
8 “Charlie Kirk Freedom of Speech Plaza”.

9 (2) REFERENCES.—Any reference in a law,
10 map, regulation, document, paper, or other record of
11 the United States to the area referred to in para-
12 graph (1) shall be deemed to be a reference to
13 “Charlie Kirk Freedom of Speech Plaza”.

14 (b) SIGNS.—

15 (1) CONSTRUCTION.—The District of Columbia
16 shall construct not less than 2 street signs that
17 shall—

18 (A) contain the phrase “Charlie Kirk Free-
19 dom of Speech Plaza”; and

20 (B) be similar in design to the signs used
21 by the District of Columbia to designate the lo-
22 cation of Metro stations.

23 (2) PLACEMENT.—Not later than 90 days after
24 the date of the enactment of this Act, the District
25 of Columbia shall place the signs constructed under

1 paragraph (1) above existing signs at the intersec-
2 tion of 16th Street Northwest and H Street North-
3 west and the intersection of 16th Street Northwest
4 and K Street Northwest.
