## A BILL

To direct each Secretary of a military department to develop a master plan for each Service Academy under the jurisdiction of the Secretary, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Developing Master  
5 Plans for Military Service Academies Act of 2025”.

6 **SEC. 2. MASTER PLANS FOR SERVICE ACADEMIES.**

7 (a) PLANS REQUIRED.—Each Secretary of a military  
8 department shall develop a master plan for each Service  
9 Academy under the jurisdiction of the Secretary to com-

1 prehensively address infrastructure requirements of such  
2 Service Academy. Each master plan shall include the fol-  
3 lowing:

4 (1) Consideration of the requirements of sub-  
5 paragraphs (A) through (D) of section 2864(a)(2) of  
6 title 10, United States Code.

7 (2) For the Service Academy that is the subject  
8 of a master plan—

9 (A) a list of infrastructure located at the  
10 Service Academy that is in poor or failing con-  
11 dition on or before the date described in sub-  
12 section (c);

13 (B) a plan for replacing, recapitalizing, or  
14 renovating such infrastructure not later than  
15 five years after such date; and

16 (C) a list of infrastructure located at the  
17 Service Academy that—

18 (i) is listed on the National Register  
19 of Historic Places (maintained under chap-  
20 ter 3021 of title 54, United States Code)  
21 on or before the date described in sub-  
22 section (b); or

23 (ii) will be eligible inclusion on the  
24 National Register of Historic Places not

1 later than five years after the date of the  
2 enactment of this Act.

3 (3) An assessment of risks posed by disruptions  
4 in energy availability, risks posed by extreme weath-  
5 er (as defined in section 101 of title 10 m United  
6 States Code), cybersecurity risks, and risks related  
7 to availability of clean water applicable to the Serv-  
8 ice Academy that is the subject of a master plan.

9 (b) ADDITIONAL REQUIREMENT.—Each master plan  
10 required under subsection (a) shall propose a method to  
11 address the requirements of paragraphs (1) and (3) of  
12 such subsection not later than five years after the date  
13 described in subsection (c).

14 (c) DEADLINE.—Each master plan required under  
15 subsection (a) shall be completed no later than September  
16 30, 2027.

17 (d) BRIEFING.—Not later than 180 days after the  
18 date of the enactment of this Act, each Secretary of a mili-  
19 tary department shall provide to the Committees on  
20 Armed Services of the Senate and the House of Represent-  
21 atives a briefing on the timeline for the completion of the  
22 master plans required under subsection (a).

23 (e) SUBMISSION OF PLAN.—Not later than 30 days  
24 after the date on which a Secretary of a military depart-  
25 ment completes a master plan required under subsection

1 (a) or December 1, 2027, whichever is earlier, the Sec-  
2 retary shall provide to the Committees on Armed Services  
3 of the Senate and the House of Representatives a copy  
4 of the master plan.

5 (f) SERVICE ACADEMY DEFINED.—In this section,  
6 the term “Service Academy” has the meaning given in sec-  
7 tion 347 of title 10, United States Code.
