A BILL

To require the Secretary of Defense to certify that the Government of Azerbaijan has taken certain meaningful steps with respect to Armenia and the Nagorno-Karabakh region, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Advancing Readiness,
5 Military Exchange, and National Integration with Arme-
6 nia Security Partnership Act Security Partnership Act”
7 or the “ARMENIA Security Partnership Act”.

1 **SEC. 2. REVIEW OF SECURITY ASSISTANCE FOR ARMENIA.**

2 (a) IN GENERAL.—Not later than 180 days after the
3 date of the enactment of this section, and not less than
4 annually thereafter, the Secretary of Defense, in coordina-
5 tion with each other national security agency such Sec-
6 retary determines appropriate, shall certify to the congres-
7 sional defense committees that the Government of Azer-
8 baijan has taken meaningful steps towards the following:

9 (1) Uphold its commitments under the Joint
10 Declaration.

11 (2) Completely withdraw all military forces
12 from the sovereign territory of Armenia.

13 (3) Unconditionally release all Armenian pris-
14 oners.

15 (4) Cease engaging in hostilities towards Arme-
16 nia.

17 (5) Recognize a right of return for ethnic Ar-
18 menians to their homes in Nagorno-Karabakh and
19 commit to the preservation of Armenian cultural and
20 religious sites in Nagorno-Karabakh.

21 (b) SECURITY ASSISTANCE REVIEW.—If the Sec-
22 retary of Defense cannot certify the information under
23 subsection (a), such Secretary shall, not later than 14
24 days after the date on which any such certification is re-
25 quired to be made, conduct an immediate review of United
26 States security assistance for the Republic of Armenia

1 (hereinafter “Armenia”) to assess gaps in Armenia’s de-
2 terrence and self-defense capabilities.

3 (c) REPORT.—Upon the completion the review re-
4 quired under subsection (b), the Secretary of Defense, in
5 coordination with the Commander of the United States
6 European Command and each other national security
7 agency such Secretary determines appropriate, shall sub-
8 mit a report to the congressional defense committees that
9 includes the following:

10 (1) An assessment of the scale and nature of
11 threats to Armenia.

12 (2) An evaluation of historical and current
13 United States security assistance for Armenia in-
14 cluding International Security Cooperation Pro-
15 grams, Foreign Military Financing, and Inter-
16 national Military Education and Training support.

17 (3) Identification of gaps in Armenia’s imme-
18 diate and long-term defense needs, including defense
19 articles, services, and military training.

20 (4) A summary of immediate steps the Depart-
21 ment of Defense is taking to increase security co-
22 operation with Armenia.

23 (5) Recommendations for further increasing se-
24 curity assistance for Armenia to address shortfalls in

1 Armenia’s self-defense capabilities to deter aggres-
2 sion.

3 (d) FREEDOM SUPPORT ACT WAIVER DISQUALI-
4 FIED.—If the Secretary of Defense cannot certify the in-
5 formation under subsection (a), the President may not,
6 after the date that is 14 days after the date on which any
7 such certification is required to be made, exercise the
8 waiver authority provided pursuant to title II of the For-
9 eign Operations, Export Financing and related Programs
10 Appropriations Act, 2002 (Public Law 107–115; 22
11 U.S.C. 5812 note) under subsection (g) under the heading
12 “Assistance for the independent states of the former So-
13 viet Union”.

14 (e) CONGRESSIONAL DEFENSE COMMITTEES DE-
15 FINED.—The term “congressional defense committees”
16 means the Committees on Armed Services and Appropria-
17 tions of the Senate and the House of Representatives.
