Mr. NEWHOUSE introduced the following bill; which was referred to the
Committee on Agriculture

A BILL

To amend the Organic Foods Production Act of 1990 to provide producers with the option to confirm the absence of prohibited substances through testing, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Meeting Demand for
5 Organic Produce Act”.

1 **SEC. 2. OPTION TO CONFIRM THE ABSENCE OF PROHIB-**
2 **ITED SUBSTANCES THROUGH TESTING.**

3 (a) NATIONAL STANDARDS FOR ORGANIC PRODUC-
4 TION.—Section 2105 of the Organic Foods Production Act
5 of 1990 (7 U.S.C. 6504) is amended—

6 (1) in the matter preceding paragraph (1)—

7 (A) by striking “shall”; and

8 (B) by striking “To be” and inserting the
9 following:

10 “(a) IN GENERAL.—To be”;

11 (2) in subsection (a) (as so designated)—

12 (A) in paragraph (1), by inserting “shall”
13 before “have been”;

14 (B) in paragraph (2)—

15 (i) by striking “products; and” and
16 inserting “product; or”;

17 (ii) by striking “livestock, not” and
18 inserting the following: “livestock—

19 “(A) shall not”; and

20 (iii) by adding at the end the fol-
21 lowing:

22 “(B) shall be produced in soil or another
23 growing medium that has been confirmed prior
24 to the time of planting to contain no prohibited
25 substances, including synthetic chemicals,
26 through testing or other methods certified by

1 the Secretary to verify the absence of prohibited
2 substances in the growing medium; and”;

3 (C) in paragraph (3), by inserting “shall”
4 before “be produced”; and

5 (3) by adding at the end the following:

6 “(b) GUIDELINES AND CRITERIA.—Not later than 60
7 days after the date of enactment of the Meeting Demand
8 for Organic Produce Act, the Secretary shall issue an ad-
9 vanced notice of proposed rulemaking to develop guide-
10 lines and criteria for approved verification methods de-
11 scribed in subsection (a)(2)(B) to ensure accuracy and re-
12 liability with respect to the testing described in that sub-
13 section.”.

14 (b) MANAGEMENT OF WILD CROPS.—Section
15 2114(f) of the Organic Foods Production Act of 1990 (7
16 U.S.C. 6513(f)) is amended—

17 (1) by redesignating paragraphs (1) through
18 (4) as subparagraphs (A) through (D), respectively,
19 and indenting appropriately;

20 (2) in the matter preceding subparagraph (A)
21 (as so redesignated), by striking “An organic” and
22 inserting the following:

23 “(1) IN GENERAL.—An organic”;

24 (3) in paragraph (1)(B) (as so redesignated)—

1 (A) by adding “or” after the semicolon at
2 the end;

3 (B) by striking “include a 3 year” and in-
4 serting the following: “include—

5 “(i) a 3-year”; and

6 (C) by adding at the end the following:

7 “(ii) a certification that the soil or
8 other growing medium of the area has
9 been confirmed prior to the time of plant-
10 ing to contain no prohibited substances, in-
11 cluding synthetic chemicals, through test-
12 ing or other methods certified by the Sec-
13 retary to verify the absence of prohibited
14 substances in the growing medium;”; and

15 (4) by adding at the end the following:

16 “(2) GUIDELINES AND CRITERIA.—Not later
17 than 60 days after the date of enactment of the
18 Meeting Demand for Organic Produce Act, the Sec-
19 retary shall issue an advanced notice of proposed
20 rulemaking to develop guidelines and criteria for ap-
21 proved verification methods described in paragraph
22 (1)(B)(ii) to ensure accuracy and reliability with re-
23 spect to the testing described in that paragraph.”.
