## A BILL

To amend the Public Health Service Act to reauthorize the WISEWOMAN program.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Women’s Heart Health  
5 Expansion Act of 2026”.

6 **SEC. 2. REAUTHORIZATION OF WISEWOMAN PROGRAM.**

7 Section 1509 of the Public Health Service Act (42  
8 U.S.C. 300n–4a) is amended to read as follows:

1 **“SEC. 1509. SUPPLEMENTAL GRANTS FOR ADDITIONAL**  
2 **PREVENTIVE HEALTH SERVICES.**

3 “(a) SCREENING AND REFERRAL PROJECTS.—The  
4 Secretary, acting through the Director of the Centers for  
5 Disease Control and Prevention, may award supplemental  
6 grants to recipients of grants under section 1501 to carry  
7 out projects for the purposes of—

8 “(1) providing preventive health services in ad-  
9 dition to the services authorized in such section, in-  
10 cluding—

11 “(A) screenings regarding blood pressure  
12 and cholesterol; and

13 “(B) health education;

14 “(2) providing appropriate referrals for medical  
15 treatment of women receiving services pursuant to  
16 paragraph (1) and ensuring, to the extent prac-  
17 ticable, the provision of appropriate follow-up serv-  
18 ices; and

19 “(3) evaluating activities conducted under para-  
20 graphs (1) and (2) through appropriate surveillance  
21 or program-monitoring activities.

22 “(b) ELIGIBILITY FOR SERVICES.—Women eligible  
23 for services pursuant to a grant under subsection (a) shall  
24 include—

25 “(1) women receiving services pursuant to a  
26 grant made under section 1501; and

1           “(2) other women who are low-income and meet  
2           such eligibility criteria as the Secretary may specify.

3           “(c) AUTHORIZED PROVIDERS.—Services provided  
4 pursuant to a grant under subsection (a) shall be provided  
5 by—

6           “(1) an entity screening women for breast and  
7           cervical cancer pursuant to a grant under section  
8           1501; or

9           “(2) other entities that the grant recipient may  
10          designate, subject to the approval of such designa-  
11          tion by the Secretary.

12          “(d) FUNDING.—To carry out this section, there is  
13 authorized to be appropriated \$250,000,000 for the period  
14 of fiscal years 2027 through 2031.”.
