# **A BILL**

To amend the Energy Act of 2020 to include critical materials in the definition of critical mineral, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
 2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       *This Act may be cited as the “Critical Mineral Con-*  
 5       *sistency Act of 2025”.*

6       **SEC. 2. CRITICAL MINERALS AND MATERIALS LIST.**

7       *Section 7002 of the Energy Act of 2020 (30 U.S.C.*  
 8       *1606) is amended—*

9               *(1) in subsection (c)(4)(C), by inserting “min-*  
 10       *erals or materials” after “critical”;*

11              *(2) by redesignating subsection (o) as subsection*  
 12       *(p); and*

13              *(3) by inserting after subsection (n) the fol-*  
 14       *lowing:*

15       *“(o) CRITICAL MINERALS AND MATERIALS LIST.—*

16              *“(1) IN GENERAL.—Not later than 45 days after*  
 17       *the date of enactment of the Critical Mineral Consist-*  
 18       *ency Act of 2025, the Secretary shall publish a Crit-*  
 19       *ical Minerals and Materials List, which shall in-*  
 20       *clude—*

21              *“(A) any critical mineral designated by the*  
 22       *Secretary under subsection (c); and*

23              *“(B) any non-fuel mineral, element, sub-*  
 24       *stance, or material that the Secretary of Energy*

1           *has determined to be a critical material under*  
2           *subsection (a)(2) as of that date of enactment.*

3           “(2) *UPDATES.*—*The Secretary shall update the*  
4           *Critical Minerals and Materials List published under*  
5           *paragraph (1)—*

6                     *“(A) not later than 45 days after the date*  
7                     *on which the Secretary updates a critical min-*  
8                     *eral designation under subsection (c); and*

9                     *“(B) not later than 45 days after the date*  
10                    *on which the Secretary of Energy updates a crit-*  
11                    *ical material designation under subsection*  
12                    *(a)(2).*

13           “(3) *PUBLICATION ALIGNMENT.*—*To the max-*  
14           *imum extent practicable, the Secretary and the Sec-*  
15           *retary of Energy shall coordinate when updates to the*  
16           *Critical Minerals and Materials List may be required*  
17           *under paragraph (2).*

18           “(4) *ADMINISTRATION.*—*For the purposes of ad-*  
19           *ministering programs involving critical minerals or*  
20           *critical materials, the Secretary, the Secretary of En-*  
21           *ergy, and the heads of other Federal departments and*  
22           *agencies where such department or agency has incor-*  
23           *porated by reference the definition of ‘critical min-*  
24           *eral’ or ‘critical material’ from this section, as appli-*  
25           *cable, shall use the most recently published version of*

- 1       *the Critical Minerals and Materials List published*
- 2       *under paragraph (1).”.*

Amend the title so as to read: “A bill to amend the Energy Act of 2020 to harmonize the lists of critical minerals and critical materials, and for other purposes.”.
