Mrs. FOUSHEE (for herself and Mr. MACKENZIE) introduced the following bill;
which was referred to the Committee on Armed Services

A BILL

To direct the Secretary of Defense to provide funds to the National Diaper Bank Network for the establishment of a Military Family Diaper Fund to provide diapers and diapering supplies to military families in need, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Military Family Diaper
5 Partnership Act”.

1 **SEC. 2. PROVISION OF FUNDS FOR ESTABLISHMENT OF**
2 **MILITARY FAMILY DIAPER FUND.**

3 (a) PROVISION OF FUNDS.—The Secretary of De-
4 fense shall seek to enter an agreement with the National
5 Diaper Bank Network to provide to the Network
6 \$1,000,000 for each of fiscal years 2027 through 2030
7 for the purpose of establishing a military family diaper
8 fund to distribute diapers and diapering supplies to mili-
9 tary families.

10 (b) USE OF FUNDS.—An agreement under subsection
11 (a) shall provide that—

12 (1) the National Diaper Bank Network shall es-
13 tablish a military family diaper fund and deposit
14 funds received from the Secretary under the agree-
15 ment into such fund;

16 (2) the National Diaper Bank Network shall
17 deposit into the military family diaper fund match-
18 ing funds or in-kind contributions from non-Federal
19 Government sources that are of a value equal or
20 greater to the amount of funds provided by the Sec-
21 retary under the agreement;

22 (3) funds or in-kind contributions in the mili-
23 tary family diaper fund shall only be provided to
24 members of the National Diaper Bank Network who
25 have engaged in the distribution of diapers or dia-
26 pering supplies in an area located within 20 miles of

1 a military installation for a period of not less than
2 five years;

3 (4) such funds or in-kind contributions shall
4 only be used—

5 (A) to provide diapers and diapering sup-
6 plies to military families in need of diapers or
7 diapering supplies; or

8 (B) for technical assistance and evaluation
9 provided by the National Diaper Bank Net-
10 work; and

11 (5) the National Diaper Bank Network shall
12 submit to the Secretary of Defense an annual report
13 on the activities carried out using the military family
14 diaper fund during the preceding fiscal year.
