# A BILL

To authorize the Director of the National Museum of African American History and Culture to support African American history education programs, and for other purposes.

1        *Be it enacted by the Senate and House of Representa-*  
2        *tives of the United States of America in Congress assembled,*

3        **SECTION 1. SHORT TITLE.**

4        This Act may be cited as the “African American His-  
5        tory Act of 2026”.

6        **SEC. 2. DEFINITIONS.**

7        In this Act:

8            (1) AFRICAN AMERICAN HISTORY.—The term  
9            “African American history” means the history of Af-  
10          rican Americans, including the history of African  
11          peoples beginning in the African diaspora through  
12          the present day, that illuminates the passage to the  
13          Americas, slavery, abolition, reconstruction, and the  
14          civil rights movements. This history also includes a  
15          focus on the innovations and contributions of Afri-  
16          can Americans to society both past and present, and  
17          the impact of African Americans on the history and  
18          development of the United States.

19          (2) AFRICAN AMERICAN HISTORY EDUCATION  
20          PROGRAM.—The term “African American history  
21          education program” means an educational program

1 relating to African American life, art, history, and  
2 culture, including programs—

3 (A) using digital, electronic, and inter-  
4 active technologies; and

5 (B) carried out in collaboration with ele-  
6 mentary schools, secondary schools, and post-  
7 secondary schools.

8 (3) DIRECTOR.—The term “Director” means  
9 the Director of the National Museum of African  
10 American History and Culture.

11 (4) ESEA TERMS.—The terms “early childhood  
12 education program”, “elementary school”, “local  
13 educational agency”, and “secondary school” have  
14 the meaning given such terms in section 8101 of the  
15 Elementary and Secondary Education Act of 1965  
16 (20 U.S.C. 7801).

17 **SEC. 3. PROGRAM AUTHORIZED.**

18 (a) IN GENERAL.—The Director, in accordance with  
19 any program of the National Museum of African American  
20 History and Culture established before, on, or after the  
21 date of the enactment of this Act, may use the funds ap-  
22 propriated under section 5 to carry out any of the fol-  
23 lowing activities at the discretion of the Director:

24 (1) Developing and making available accurate,  
25 relevant, and accessible resources to promote the un-

1       derstanding of African American history, which may  
2       include digital resources and other types of re-  
3       sources, such as print resources and traveling exhibi-  
4       tions.

5               (2) Through a social justice and anti-bias lens,  
6       convening experts, providing opportunities for dis-  
7       course, and engaging with the public through pro-  
8       gramming, educational resources, and social media.

9               (3) Through a social justice and anti-bias lens,  
10      increasing resource capacity, technical support, and  
11      content creation to engage various audiences in per-  
12      son and via online platforms.

13              (4) Creating, expanding, and disseminating  
14      scholarly work through research, curricula, in-house  
15      and traveling exhibitions, publications, and program-  
16      ming.

17              (5) Providing language translation of the work  
18      of the National Museum of African American His-  
19      tory and Culture, including scholarly work, research,  
20      traveling exhibitions, publications, programming,  
21      pamphlets, and other information distributed about  
22      activities funded under this Act.

23              (6) Expanding the collection acquisition and  
24      collection access processes, including staffing, con-  
25      servation, processing, and digitization.

1           (7) Augmenting one or more of the following  
2 African American history education program activi-  
3 ties:

4           (A) Development, dissemination, and im-  
5 plementation of principles of sound pedagogy  
6 for teaching about African American history.

7           (B) Provision of professional development,  
8 such as, but not limited to, through—

9           (i) local, regional, and national work-  
10 shops;

11           (ii) teacher trainings or engagement  
12 in conjunction with African American his-  
13 tory education centers and other appro-  
14 priate partners;

15           (iii) engagement with—

16           (I) local educational agencies;

17           and

18           (II) early childhood education  
19 programs, elementary schools, and  
20 secondary schools that are inde-  
21 pendent of any local educational agen-  
22 cy; and

23           (iv) operation and expansion of a  
24 teacher fellowship program to cultivate and

1 support leaders in African American his-  
2 tory education.

3 (C) Engagement with State and local edu-  
4 cation leaders to encourage the adoption of re-  
5 sources supported under this Act into curricula  
6 across diverse disciplines.

7 (8) Creating, developing, implementing, repli-  
8 cating, or taking to scale entrepreneurial, evidence-  
9 based, field-initiated innovations for museum im-  
10 provement, and evaluating rigorously such innova-  
11 tions.

12 (b) ONLINE AFRICAN AMERICAN HISTORY EDU-  
13 CATION RESOURCES.—

14 (1) WEBSITE.—The Director may use the funds  
15 appropriated under section 5 to develop and main-  
16 tain on the website of the National Museum of Afri-  
17 can American History and Culture content des-  
18 ignated for educators, students, and families to im-  
19 prove their awareness and understanding of African  
20 American history.

21 (2) INFORMATION DISTRIBUTION.—The Direc-  
22 tor may use such funds to distribute information  
23 about the activities funded under this Act through  
24 the website of the National Museum of African  
25 American History and Culture, and may respond to

1 inquiries for supplementary information concerning  
2 such activities.

3 (c) CONTINUATION OF ACTIVITIES.—To the extent  
4 that the National Museum of African American History  
5 and Culture is engaged in an activity described in sub-  
6 section (a) or (b) on the date of the enactment of this  
7 Act, the Director may use the funds appropriated under  
8 section 5 to continue that activity.

9 **SEC. 4. ANNUAL REPORT AND BRIEFINGS.**

10 (a) REPORT.—Not later than February 1 of each  
11 year, the Director shall submit to the Congress, and make  
12 available to the public, a report describing how the funds  
13 made available under this Act have been used—

14 (1) to create and promote educational activities;

15 and

16 (2) otherwise to carry out this Act.

17 (b) BRIEFINGS.—Not later than 6 months after the  
18 date on which funding is first distributed under this Act,  
19 and annually thereafter, the Director or the Director's  
20 designee shall brief the Committee on House Administra-  
21 tion of the House of Representatives and the Committee  
22 on Rules and Administration of the Senate on the pro-  
23 grams and activities carried out under this Act.

24 (c) SUNSET.—Subsections (a) and (b) shall cease to  
25 be effective on September 30, 2030.

1 **SEC. 5. SENSE OF CONGRESS.**

2 It is the sense of Congress that—

3 (1) the significance of accurate education of the  
4 history of minority groups in America through a so-  
5 cial justice and anti-bias lens should be recognized,  
6 and the United States Federal Government should  
7 strive for a leadership role in initiatives aimed at im-  
8 proving the teaching of African American, Hispanic  
9 and Latino, Asian American and Pacific Islander,  
10 and Native American history;

11 (2) the Director of the Smithsonian Museum of  
12 the American Indian should be empowered to de-  
13 velop and disseminate historically accurate materials  
14 aimed at improving the teaching of Native American  
15 history; and

16 (3) the Directors of the forthcoming Smithso-  
17 nian American Women's History Museum and the  
18 forthcoming Smithsonian National Museum of the  
19 American Latino, as well as the directors of any fu-  
20 ture Smithsonian Museums covering the history of  
21 minority groups in America, should be empowered to  
22 create and disseminate quality education materials  
23 in their areas of expertise.

1 **SEC. 6. AUTHORIZATION OF APPROPRIATIONS.**

2       There are authorized to be appropriated to carry out  
3 this Act \$4,000,000 for fiscal year 2027 and each of the  
4 4 succeeding fiscal years.
