A BILL

To amend the Patient Protection and Affordable Care Act to ensure that taxpayer funds for health insurance coverage are available only to authorized individuals, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “No Federal Tax Dol-
5 lars for Illegal Aliens Health Insurance Act of 2026”.

1 **SEC. 2. ENSURING THAT TAXPAYER FUNDS FOR HEALTH**
2 **INSURANCE COVERAGE ARE AVAILABLE**
3 **ONLY TO AUTHORIZED INDIVIDUALS.**

4 (a) IN GENERAL.—Section 1332(a)(2)(B) of the Pa-
5 tient Protection and Affordable Care Act (42 U.S.C.
6 18052(a)(2)(B)) is amended by inserting “(other than the
7 requirement described in section 1312(f)(3))” before the
8 period.

9 (b) PROHIBITION ON USE OF PASS-THROUGH FUND-
10 ING FOR CERTAIN INDIVIDUALS.—Section 1332(a)(3) of
11 the Patient Protection and Affordable Care Act (42
12 U.S.C. 18052(a)(3)) is amended by adding at the end the
13 following new sentence: “No amounts paid to a State
14 under this paragraph may be used to offset the cost of
15 health insurance coverage (including through premium or
16 cost sharing reductions) or to provide any other benefit
17 with respect to an individual who is not a citizen or na-
18 tional of the United States or an alien lawfully present
19 in the United States.”.

20 (c) RESCISSION OF CERTAIN WAIVERS.—Not later
21 than 30 days after the date of the enactment of this Act,
22 the Secretary of Health and Human Services shall rescind
23 any waiver approved under section 1332 of the Patient
24 Protection and Affordable Care Act (42 U.S.C. 18052) be-
25 fore such date that would not have been so approved had

- 1 the amendments made by this section been in effect at
- 2 the time of such approval.
