## A BILL

To direct the Secretary of the Army to place in Arlington National Cemetery a monument honoring Army Security Agency veterans of World War II, the Korean conflict, the Vietnam Era, and the Cold War era, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Army Security Agency  
5       Monument Act”.

1 **SEC. 2. PLACEMENT OF MONUMENT HONORING VETERANS**  
2 **OF THE ARMY SECURITY AGENCY WHO**  
3 **SERVED IN THE ARMED FORCES BETWEEN**  
4 **1945 AND 1976, DURING WORLD WAR II, THE**  
5 **KOREAN CONFLICT, THE VIETNAM ERA, AND**  
6 **THE COLD WAR ERA.**

7 (a) PLACEMENT.—

8 (1) IN GENERAL.—Subject to the requirements  
9 of subsection (c), the Secretary of the Army shall  
10 place in Arlington National Cemetery a monument  
11 honoring Army Security Agency veterans who served  
12 in the Armed Forces between 1945 and 1976, dur-  
13 ing World War II, the Korean conflict, the Vietnam  
14 era, and the Cold War era.

15 (2) ALTERNATIVE LOCATION.—If the Secretary  
16 of the Army is unable to identify an appropriate  
17 place in Arlington National Cemetery for the monu-  
18 ment described in paragraph (1), the Secretary shall  
19 place the monument at a location outside the en-  
20 trance to Arlington National Cemetery.

21 (b) DESIGN.—The monument placed under sub-  
22 section (a) shall be—

23 (1) based on a design approved by the Sec-  
24 retary of the Army and the National Army Security  
25 Agency Association;

26 (2) placed on a non-burial plot; and

1           (3) limited to 52 inches by 18 inches in base di-  
2           mensions.

3           (c) AGREEMENT FOR CONSTRUCTION AND MAINTENANCE.—The Secretary of the Army may only place a  
4           monument under subsection (a) if the Secretary enters  
5           into an agreement with the National Army Security Agen-  
6           cy Association under which the Association agrees to pay  
7           all costs necessary for preparation of the site for the  
8           monument and to construct, install, and maintain the  
9           monument, and to such other provisions as the Secretary  
10          may require.

12          (d) DEFINITIONS.—In this section, the terms “World  
13          War II”, “Korean conflict”, and “Vietnam era” have the  
14          meanings given such terms in section 101 of title 38,  
15          United States Code.
