## A BILL

To amend the Congressional Budget and Impoundment Control Act of 1974 to establish certain procedures for consideration of annual appropriation bills, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. PROCEDURES FOR CONSIDERATION OF AN-**  
4 **NUAL APPROPRIATION BILLS.**

5 (a) IN GENERAL.—Section 309 of the Congressional  
6 Budget and Impoundment Control Act of 1974 (2 U.S.C.  
7 640) is amended to read as follows:

1 “APPROVAL OF REGULAR APPROPRIATION BILLS

2 “SEC. 309. (a) IN THE SENATE.—

3 “(1) Except as provided in paragraph (2), the  
4 provisions of section 305 for the consideration in the  
5 Senate of concurrent resolutions on the budget and  
6 conference reports thereon shall apply to the consid-  
7 eration in the Senate of annual appropriation bills.

8 “(2) Debate in the Senate on any annual ap-  
9 propriation bill, and all amendments thereto and de-  
10 batable motions and appeals in connection therewith,  
11 shall be limited to not more than 20 hours.

12 “(3) Paragraphs (1) and (2) shall not apply to  
13 any measure providing continuing appropriations.

14 “(b) IN THE HOUSE OF REPRESENTATIVES.—It shall  
15 not be in order in the House of Representatives to consider  
16 any resolution providing for an adjournment period of  
17 more than three calendar days during the month of July  
18 until the House of Representatives has approved annual  
19 appropriation bills providing new budget authority under  
20 the jurisdiction of all the subcommittees of the Committee  
21 on Appropriations for the fiscal year beginning on October  
22 1 of such year. For purposes of this section, the chairman  
23 of the Committee on Appropriations of the House of Rep-  
24 resentatives shall periodically advise the Speaker as to

1 changes in jurisdiction among its various subcommit-  
2 tees.”.

3 (b) CONFORMING AMENDMENT.—In the table of con-  
4 tents in section 1(b) of such Act (2 U.S.C. 621 note), the  
5 item relating to section 309 is amended to read as follows:

“Sec. 309. Approval of regular appropriation bills.”.
