A BILL

To amend titles XVIII and XIX of the Social Security Act to require coverage of certain food and nutrition services under the Medicare and Medicaid programs.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. REQUIRING COVERAGE OF CERTAIN FOOD AND**
4 **NUTRITION SERVICES UNDER MEDICARE**
5 **AND MEDICAID.**

6 (a) COVERAGE UNDER MEDICARE.—

1 (1) IN GENERAL.—Section 1861(s)(2) of the
2 Social Security Act (42 U.S.C. 1395x(s)(2)) is
3 amended—

4 (A) in subparagraph (JJ), by striking
5 “and” at the end;

6 (B) in subparagraph (KK), by adding
7 “and” at the end; and

8 (C) by adding at the end the following new
9 subparagraph:

10 “(LL) food and nutrition services meeting
11 such requirements as the Secretary shall speci-
12 fy;”.

13 (2) PAYMENT.—Section 1833(a)(1) of the So-
14 cial Security Act (42 U.S.C. 1395l(a)(1)) is amend-
15 ed—

16 (A) by striking “and” before “(HH)”; and

17 (B) by inserting before the semicolon at
18 the end the following: “, and (II) with respect
19 to specified food and nutrition services under
20 section 1861(s)(2)(LL), the amounts paid shall
21 be equal to 80 percent of the actual charge for
22 the services”.

23 (3) EFFECTIVE DATE.—The amendments made
24 by this subsection shall apply to items and services

1 furnished on or after the date that is 180 days after
2 the date of the enactment of this section.

3 (b) COVERAGE UNDER MEDICAID.—

4 (1) IN GENERAL.—Section 1905(a) of the So-
5 cial Security Act (42 U.S.C. 1396d(a)) is amend-
6 ed—

7 (A) in paragraph (31), by striking “and”
8 at the end;

9 (B) by redesignating paragraph (32) as
10 paragraph (33); and

11 (C) by inserting after paragraph (31) the
12 following new paragraph:

13 “(32) food and nutrition services meeting such
14 requirements as the Secretary shall specify; and”.

15 (2) MANDATORY BENEFIT.—Section
16 1902(a)(10)(A) of the Social Security Act (42
17 U.S.C. 1396a(a)(10)(A)) is amended, in the matter
18 preceding clause (i), by striking “and (30)” and in-
19 serting “(30), and (32)”.

20 (3) EFFECTIVE DATE.—The amendments made
21 by this subsection shall apply to items and services
22 furnished on or after the date that is 180 days after
23 the date of the enactment of this section.
