## A BILL

To amend chapter 83 of title 5, United States Code, to prohibit pay of annuity or retired pay to a Member of Congress convicted of a criminal offense committed during congressional service, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Congressional Pension  
5 Integrity Act of 2026”.

1 **SEC. 2. PENSION ELIGIBILITY FOR MEMBERS OF CON-**  
2 **GRESS.**

3 (a) IN GENERAL.—Subchapter II of chapter 83 of  
4 title 5, United States Code, is amended by adding at the  
5 end the following:

6 **“§ 8323. Offenses committed by Members of Congress**

7 “(a) An individual who is or was a Member of Con-  
8 gress, or the survivor or beneficiary of such individual,  
9 may not be paid annuity or retired pay on the basis of  
10 the service of the individual which is creditable toward the  
11 annuity or retired pay, if the individual was convicted of  
12 an offense named by subsection (b) of this section, to the  
13 extent provided by the paragraph, and the prohibition on  
14 payment of annuity or retired pay applies to the period  
15 after the earlier of—

16 “(1) the date of the conviction; or

17 “(2) if applicable, the date on which the status  
18 of the individual as a Member of Congress is termi-  
19 nated.

20 “(b) Each of the following is an offense to which sub-  
21 section (a) of this section applies if the individual commits  
22 the offense, or begins committing the offense, while the  
23 individual is or was a Member of Congress:

24 “(1) Rape.

25 “(2) Sexual assault.

26 “(3) Sexual abuse of a minor.

1           “(4) Participation in a venture that causes an-  
2           other individual to engage in a sex act, on account  
3           of which anything of value is given to or received by  
4           any person, with the purpose of benefitting, whether  
5           financial or by receiving anything of value, from  
6           such participation.

7           “(5) A crime of violence, as such term is de-  
8           fined in section 16 of title 18.

9           “(6) An offense within the purview of—

10           “(A) chapter 11 (relating to bribery, graft,  
11           and conflict of interest), chapter 29 (relating to  
12           elections and political activities), chapter 31  
13           (relating to embezzlement and theft), chapter  
14           63 (relating to mail fraud and other fraud of-  
15           fenses), and chapter 73 (relating to obstruction  
16           of justice) of title 18; or

17           “(B) the Federal Election Campaign Act  
18           of 1971.

19           “(c) An individual who is or was a Member of Con-  
20           gress, or the survivor or beneficiary of such individual,  
21           may not be paid annuity or retired pay on the basis of  
22           the service of the individual which is creditable toward the  
23           annuity or retired pay, if the House of Congress with re-  
24           spect to which the individual is or was a Member of Con-  
25           gress determines, in accordance with the rules of the

1 House of Congress, that the individual engaged in sexual  
2 conduct with another individual who was, at the time of  
3 the sexual conduct, an officer or employee in or of the  
4 House of Congress under the supervision of the individual,  
5 and the prohibition on payment of annuity or retired pay  
6 applies to the period after the earlier of—

7 “(1) the date of the determination; or

8 “(2) if applicable, the date on which the status  
9 of the individual as a Member of Congress is termi-  
10 nated.

11 “(d) This section shall take effect on the date on  
12 which the next succeeding Congress begins after the date  
13 of the enactment of this section and shall apply with re-  
14 spect to such dates of conviction, determination, and ter-  
15 mination described in this section after the effective  
16 date.”.

17 (b) CONFORMING AMENDMENT.—The table of sec-  
18 tions for chapter 83 of title 5, United States Code, is  
19 amended by inserting after the item relating to section  
20 8322 the following:

“8323. Offenses committed by Members of Congress.”.
