A BILL

To provide for the transfer of administrative jurisdiction
over certain Federal land in the State of California,
and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. TRANSFER OF ADMINISTRATIVE JURISDICTION**
 4 **OVER CERTAIN FEDERAL LAND IN THE STATE**
 5 **OF CALIFORNIA.**

6 *(a) TRANSFER OF ADMINISTRATIVE JURISDICTION.—*

7 *(1) NATIONAL FOREST SYSTEM LAND.—Adminis-*
 8 *trative jurisdiction over the approximately 160 acres*
 9 *of National Forest System land more particularly de-*
 10 *scribed as T.1 S., R.19 E., sec. 24, SE¹/₄NE¹/₄,*
 11 *NW¹/₄SE¹/₄, NE¹/₄SE¹/₄, and SE¹/₄SE¹/₄, Mount Dia-*
 12 *blo Meridian, Tuolumne County, California, as gen-*
 13 *erally depicted on the map entitled “Ackerson Mead-*
 14 *ow Land Interchange” and dated February 24, 2022,*
 15 *is transferred to the Secretary of the Interior to be*
 16 *managed as part of Yosemite National Park, in ac-*
 17 *cordance with laws applicable to the National Park*
 18 *System.*

19 *(2) NATIONAL PARK SYSTEM LAND.—Adminis-*
 20 *trative jurisdiction over the approximately 170 acres*
 21 *of National Park System land more particularly de-*
 22 *scribed as the SE¹/₄ of sec. 23 and the land to the*
 23 *north and west of Road 1S25 within the*
 24 *NW¹/₄SE¹/₄NW¹/₄ of sec. 24, T.1 S., R. 19 E., Mount*
 25 *Diablo Meridian, Tuolumne County, California, as*

1 *generally depicted on the map entitled “Ackerson*
2 *Meadow Land Interchange” and dated February 24,*
3 *2022, is transferred to the Secretary of Agriculture to*
4 *be managed as part of Stanislaus National Forest in*
5 *accordance with laws applicable to the National For-*
6 *est System.*

7 *(b) CORRECTIONS.—*

8 *(1) MINOR ADJUSTMENTS.—The Secretary of Ag-*
9 *riculture and the Secretary of the Interior may, by*
10 *mutual agreement, make minor corrections and ad-*
11 *justments to the Federal land transferred under sub-*
12 *section (a) to facilitate land management, including*
13 *making a correction or adjustment to any applicable*
14 *survey.*

15 *(2) PUBLICATIONS.—Any correction or adjust-*
16 *ment made under paragraph (1) shall be effective on*
17 *the date of publication of a notice of the correction or*
18 *adjustment in the Federal Register.*

19 *(c) EFFECT ON EXISTING RIGHTS AND AUTHORIZA-*
20 *TIONS.—Nothing in this section affects—*

21 *(1) any valid existing rights; or*

22 *(2) the validity or terms and conditions of any*
23 *existing withdrawal, right-of-way, easement, lease, li-*
24 *cense, or permit on the land to which administrative*
25 *jurisdiction is transferred under this section, except*

1 *that beginning on the date of enactment of this Act,*
2 *the head of the agency to which administrative juris-*
3 *diction over the land is transferred shall be respon-*
4 *sible for administering the interests or authorizations*
5 *in accordance with applicable law.*
